Dear Mr. Feeney:

In order to discharge the Wenatchee City Attorney's duties stated by the United States Supreme Court in *Brady v. Maryland*, 373 U.S. 83 (1963), *Giglio v. United States*, 405 U.S. 150 (1972), and *Kyles v. Whitely*, 514 U.S. 419 (1995), and as required in CrRLJ 4.7 and RPC 3.8, it has been determined that the Wenatchee Police Department possesses certain documents that contain potential impeachment material that relate to East Wenatchee Police Officer Tye Sheats. Specifically, in a pre-employment screening examination report done by Everett Polygraph Services, LLC and dated May 13, 2016, it states that Officer Sheats disclosed the following:

1. Between 2000-2005, Officer Sheats shoplifted from stores on approximately 20 occasions;
2. In 2001, Officer Sheats stole a pair of sunglasses from a friend;
3. In 2003 or 2004, Officer Sheats entered an unlocked vehicle in Port Angeles and stole a radar detector;
4. In 2004, Officer Sheats entered another vehicle and stole interior parts;
5. In 2004, Officer Sheats stole a rear bumper off a vehicle that he described as "destroyed and left in the mountains";
6. In 2007, Officer Sheats stole nuts and bolts from his employer;

7. In 2010, Officer Sheats stole "defective" sockets from his employer and used his employer tool repair kits for the sockets without permission;
8. From 2008 to 2013, Officer Sheats altered sale prices on vehicle titles to avoid paying higher sales tax;
9. In 2009, Officer Sheats filed a false or misleading auto insurance claim;
10. In 2009 or 2010, Officer Sheats fraudulently received free television cable services for his mother's residence;
11. In 2011, Officer Sheats kept for his own personal use a pair of gloves that he found on duty while investigating a possible vehicle prowler crime;
12. In 2012, while on duty, Officer Sheats kept for his own personal use a multi-tool that he removed from a driver during a traffic stop; and
13. In 2016, Officer Sheats falsified traffic stop statistics at East Wenatchee Police Department.
