My concerns are about how Saturday was handled. I do not have any plans on forwarding my concerns to Donna or Chris. I do not plan on having any contact with them. I will leave that to my attorney. After Saturday I do not have confidence the administration will protect B. The administration did not protect B. on Saturday. Coach Jordan did not protect B. on Saturday. Jordan basically told her she had a job to do and to get on her box and that is what she did with tears in her eyes. That is not acceptable. The administrators hugged and gave the boy who raped my daughter cookies. Donna Hood had a police officer threaten to have me taken to jail and would not allow me to get my daughter off the field. Again, not acceptable.

The school district has the ability to ban B Lagrange from all Skyline activities. There is no reason for him to attend Skyline events; he is not a student, he has no siblings at Skyline, he isn't an alumni. He has been convicted of sexual assault and that is enough for the ISD to ban him if they choose to. But, instead they chose to hug him, give him cookies and let him and his friends sit in the student section and glare at my daughter. This will continue to happen at every athletic event just because B can now, and the administration has chosen to let him do it.

Also, my understanding is an administrator is supposed to be at cheer practices until the investigation with Kand Rais complete, which makes it worse because I do not want any of the administrators around my daughter.

Stephania, this whole situation is unfortunate and I am saddened by the choices the administration has made. I'm not upset with you and I do believe the safety of your girl's is of the utmost importance to you. However, Band I no longer trust that the administration does.
