14		friends with all of my employees, but I am their boss.
15		I am the sheriff, and they're still my employees.
16	Q.	So was there a period of time when you were friends with
17		Stephen Parker?
18	Α.	Again, I I can't answer that, because I'm not sure
19		what you mean by friends.
20	Q.	Have you heard the word "friends" before?
21	A.	I have.
22	Q.	Have you ever used the word "friends" before?
23	Α.	I have.
24	Q.	Do you have any friends?
25	Α.	I do.

4		and Natalia Garcia, was the San Juan County Sheriff's
5		Office an accredited law enforcement agency?
6	A.	No.
7	Q.	Is the San Juan County Sheriff's Office currently an
8		accredited law enforcement agency?
9	A.	No.
10	Q.	As the sheriff of the San Juan County Sheriff's Office,
11		do you think that the people of San Juan County deserve
12		an accredited law enforcement agency?
13	A.	Yes.
14	Q.	Why isn't the San Juan County Sheriff's Office an
15		accredited law enforcement agency?
16	A.	We're currently working on that.
17	Q.	When will the San Juan County Sheriff's Office become an
18		accredited law enforcement agency?
19	A.	I don't have that answer.
20	Q.	What do you need to accomplish as an agency before you
21		can become accredited?
22	A.	There's a long process you have to go through. You have
23		to go through the accredidation [sic] process, which
24		takes time.
25	Q.	Does the accredidation process require you to have a

1		functioning policy and procedure manual?
2	А.	It does.
3		
	Q.	Does that policy and procedure manual require you to
4		have policies that say, for example, prohibit deputies
5		from having sex with witnesses in cases they're
6		investigating?
7	A.	I would assume so.
8	Q.	Have you reviewed the new policy and procedure manual
9		for I'll start over.
10		Do you have the new Lexipol policy and procedure
11		manual in place for the San Juan County Sheriff's Office
12		currently?
13	A.	We do.
14	Q.	Have you reviewed it, every page?
15	A.	Not every, single page, no.
16	Q.	So you put into place a policy and procedure manual that
17		you didn't even completely review?
18	A.	Yeah.
19		My undersheriff and sergeants have reviewed it,
20		and I have walked through it with them.
21	Q.	Do you think, as the chief law enforcement officer for
22		San Juan County, before you put policies and procedures
23		into place for the county you have an obligation to
24		review the entire policy and procedure manual you're
25		putting into place?

1 Α. Yes. 2 Yet you didn't do it. Ο. 3 Α. No. 4 Why not? Ο. 5 Α. I don't have an answer for you. 6 MR. COOLEY: With no question pending, I'm going 7 to ask for a quick break. 8 THE VIDEOGRAPHER: I'm off the record. 9 (At 10:59 a.m. a recess was taken until 10 11:01 a.m.) 11 THE VIDEOGRAPHER: I'm back on the record. BY MR. LEE: 12 13 Earlier you agreed that all of your deputies would have Ο. 14 known that it was inappropriate to have a sexual affair 15 with a witness or victim in a case that they were 16 investigating. Would you agree that it was because such 17 conduct was obviously inappropriate, regardless of 18 whether or not a policy was formally put in place? 19 Α. Yes. 20 Are you aware of any other occasion in the San Juan Ο. 21 County Sheriff's Office where one of your deputies had a 22 sexual affair or encounter with a victim or witness in a 23 case they were investigating? 24 Α. No. 25 If you personally were on trial and had been accused of Q.

1 a crime, would you want to know if the officer who 2 conducted the investigation was having an affair with 3 the complaining witness? 4 MR. COOLEY: Object to the form. Calls for 5 speculation. It's a hypothetical without facts in 6 evidence. 7 THE WITNESS: Yeah. I'm not -- yes. I'm not 8 going to answer a hypothetical. BY MR. LEE: 9 10 So you are going to answer. The question is: If you 0. 11 were on trial and the deputy conducting the 12 investigation you were on trial for was having an affair 13 with the complaining witness, would you want to know 14 that during the trial? 15 MR. COOLEY: Same objection. 16 THE WITNESS: Yes. I would want to know that, 17 yes. 18 BY MR. LEE: 19 And why would you want to know that? Ο. 20 For the appearance of fairness. Α. 21 Ο. And for fairness itself. Right? 22 Correct. Well, yes. That's what I meant. Α. 23 Ο. Do you believe that the failure of Stephen Parker to 24 disclose this alleged affair to Dr. Tinner during his 25 trial denied Dr. Tinner a fair trial?

1 MR. McMAHON: Object to the form of the 2 question. Calls for legal conclusion. 3 THE WITNESS: Yeah. 4 MR. COOLEY: Join. 5 THE WITNESS: I don't -- I have no way of б answering that. 7 BY MR. LEE: 8 Do you believe that Dr. Tinner received a fair trial? Ο. 9 Α. No. 10 MR. McMAHON: Object to form. BY MR. LEE: 11 12 Did you ever hear prosecutor Randy Gaylord say that Q. Dr. Tinner received a fair trial? 13 14 Α. I don't -- I don't know. Is it possible that Randy Gaylord said that Dr. Tinner 15 Q. 16 received a fair trial and you've simply forgotten 17 hearing him say that? 18 MR. COOLEY: Object to the form. Calls for 19 speculation. 20 THE WITNESS: Anything is possible. 21 BY MR. LEE: 22 Did you have any discussions with Randy Gaylord at any Q. 23 point about whether or not Dr. Tinner received a fair 24 trial? 25 Α. No.

1 Ο. Did you have any discussions with Randy Gaylord at any 2 point about why the case against Dr. Tinner was 3 dismissed? 4 Α. No. 5 Would you agree that the case against Dr. Tinner was the 0. 6 most high-profile case in San Juan County in the time 7 that you have served in any capacity in law enforcement 8 for San Juan County? 9 Α. No. 10 MR. COOLEY: Object to form. 11 Okay. Sorry. 12 THE WITNESS: I'm sorry. 13 MR. COOLEY: You did fine. But give a little 14 pause so I can get it in. I don't need an objection, 15 given your answer. 16 BY MR. LEE: 17 Is there a more high-profile case in San Juan County in Ο. 18 your time as the elected sheriff than the one against 19 Dr. Tinner? 20 Object to the form. Calls for MR. COOLEY: 21 speculation. Vague, what you mean by "high profile." 22 THE WITNESS: So we've had a number of cases in 23 San Juan County since I've been the sheriff, two of 24 which were homicide cases. In my view are pretty big 25 cases.

1 BY MR. LEE:

2 Did either of those cases get dismissed? Ο. 3 Α. No. 4 What is the most significant dismissal of a felony case, Ο. 5 in your estimation, in your time as sheriff? б Α. I think the only felony case that I can think of that's 7 been dismissed is this case. 8 Ο. Okay. So in your time as sheriff for San Juan County 9 you're aware of one felony case being dismissed, and 10 that case is State of Washington versus Gerald Tinner. 11 Right? 12 Α. Correct. 13 And that's the case where your deputy is alleged to have Ο. 14 had an affair with the complaining witness. Right? 15 Alleged, yes. Α. 16 And you, in fact, believe that he did have that affair. Ο. 17 Right? 18 Α. Correct. 19 MR. McMAHON: Object to the form. 20 BY MR. LEE: 21 Ο. And when you became aware that the case against 22 Dr. Tinner was dismissed, did you have any discussions 23 with Randy Gaylord about why this one case was 24 dismissed? 25 Α. I've already answered that question. I'm going to stand

1 by my answer. I don't want to change it. 2 How long was Dr. Tinner incarcerated in the San Juan Q. 3 County jail? 4 Α. I don't know. 5 Are you aware that he was incarcerated in the San Juan 0. 6 County jail? 7 Α. Yes. 8 Ο. Do you know when he was booked into your jail? 9 Α. No. 10 Ο. Do you know when Dr. Tinner was released from your jail? 11 Α. No. 12 Excuse me. Can we take a break for a second? 13 MR. COOLEY: Yeah. 14 THE VIDEOGRAPHER: I'm off the record. 15 (At 11:07 a.m. a recess was taken until 16 11:09 a.m.) 17 MR. McMAHON: In situations where you're having 18 difficulty hearing either Mr. Cooley or myself joining 19 in objection, consider Detective Parker to join in that 20 objection so it's on the record. 21 MR. COOLEY: Sorry, guys. I have to go off the 22 record. I have an emergency of my own. 23 (At 11:09 a.m. a recess was taken until 24 11:14 a.m.) THE VIDEOGRAPHER: I'm back on the record. 25

1 BY MR. LEE: 2 Sheriff, when did you first learn that Natalie Garcia Ο. 3 had alleged a sexual affair with Detective Parker? 4 I don't know the date. Α. 5 Where were you physically located when you learned that 0. 6 Natalie Garcia had alleged a sexual affair between her 7 and Detective Parker? 8 Α. In the prosecutor's office. 9 Did you just happen to be in the prosecutor's office, or Q. 10 did somebody call you over? 11 No. Teresa called me over. Α. 12 Teresa who? Ο. 13 Zueger or -- wait a minute. Yeah. I believe it was --Α. 14 one of the deputy prosecutors called me over. 15 Is Teresa Zueger a deputy prosecutor? Q. 16 She is. Α. 17 And how far away from your sheriff's office is the Ο. 18 prosecuting attorney's office? 19 Α. 50 feet. 20 Did she call you on the telephone? Ο. 21 I don't recall. Α. 22 Did she walk over to your office and say: I need you to 0. 23 come to my office? 24 I don't recall how they notified me. Α. 25 But you believe it was Teresa? Q.

1	A.	Yes. That's my recollection. It was Teresa that
2		contacted either contacted me or contacted my office
3		to ask me to come over.
4	Q.	And did they tell you what it was regarding when you
5		came over?
6	Α.	When I came over.
7	Q.	When they asked you to come over.
8	A.	No.
9	Q.	They just said, "We need to talk to you about something"
10		and "Come over."
11	A.	Yes.
12	Q.	So you came over and met with who?
13	Α.	I believe it was Teresa. I met with, I believe, Teresa.
14		Might have been one other person there, but I don't
15		recall who that was.
16	Q.	And what did she tell you?
17	Α.	That Natalia had disclosed to one of the victim
18		advocates that she was, I believe, in love or maybe in
19		love and had an affair or was having a was in a
20		relationship I think is how it was maybe worded with
21		Detective Parker.
22	Q.	And was Teresa a part of the team that prosecuted
23		Dr. Tinner?
24	A.	I don't remember.
25	Q.	And did she tell you why she was bringing this to your

1 attention? 2 No. Α. 3 So she just said: FYI, Natalie Garcia says she's having Q. 4 an affair with Stephen Parker. Just thought you should 5 know? 6 Α. Well, it's one of my employees. It would be appropriate 7 for her to notify me that one of my employees engaged in 8 potential misconduct, regardless of what the conduct is. 9 And so that's what she did. She just said: FYI, this Q. 10 is the allegation? 11 Yes. Α. And how did you respond to her? 12 Ο. 13 I don't recall. I believe I was shocked. Α. 14 Then we -- I set plans to have Skagit County do 15 an investigation on it. And that's when I left and 16 walked back over, and then I believe I met with my 17 undersheriff and then went and informed Detective Parker 18 that he was being investigated. 19 Did Teresa tell you whether or not Randy Gaylord was Ο. 20 aware of the allegation against Stephen Parker at that 21 time? I don't recall. 22 Α. 23 Ο. Was Randy Gaylord personally involved in the prosecution 24 of Dr. Tinner, to your knowledge? 25 Yes. I believe he was. Α.

1	Q.	Was he trial counsel?
2	Α.	I believe so.
3	Q.	Did you ask Teresa if prosecutor Gaylord was aware of
4		the allegation?
5	Α.	I don't recall.
6	Q.	And your immediate response was to go talk to your
7		undersheriff?
8	Α.	Correct.
9	Q.	What did you say to him?
10	Α.	I don't recall.
11	Q.	What did your undersheriff say to you?
12	Α.	I don't recall.
13	Q.	And whose decision was it to not put Detective Parker on
14		administrative leave?
15	Α.	That would be my decision.
16	Q.	Did the undersheriff recommend that an outside
17		investigation be conducted?
18	Α.	No.
19	Q.	So did you say that when you spoke to Teresa you agreed
20		that you would have an outside agency conduct an
21		investigation of the allegation against Stephen Parker?
22	Α.	Yes.
23	Q.	So the first person who notifies you of it, the first
24		thing you say is "We're going to have an outside agency
25		investigate"?
		77
1		, ,

1 Α. That may not have been the first thing that's said. We 2 were in the office for a while, and I remember talking 3 to her about a number of things in regards to this 4 allegation and getting some background on it, I believe. 5 So I'm sure it wasn't the first thing out of my mouth, 6 but at the end of the meeting it was determined, I said 7 we're going to have an outside agency investigate it. 8 The meeting wasn't, like, a 30-second meeting, 9 she tells me, I say we're going to do this, and then I 10 leave. It was -- we were -- my recollection is we were 11 there for a while, probably discussing different --12 discussing the issue at hand. 13 What else did you discuss? Ο. I don't recall. 14 Α. 15 But you recall that that discussion took about Ο. 16 30 minutes? 17 Maybe. I don't recall the exact amount of time. Α. I just 18 know it was -- it was a lot more than a brief amount of 19 time. 20 And during that discussion between you and Teresa, you Ο. 21 collectively or individually came to a decision that an 22 outside investigation would be done on the allegation 23 against Stephen Parker. 24 It would have probably been individually, but -- I don't Α. 25 recall how it came up. But I believe it would have been

1		my decision and something I came up with, I believe.
2	Q.	You don't recall if it was her idea or your idea to
3		conduct an have an outside investigation conducted?
4	Α.	I don't.
5	Q.	But you do recall the initial meeting where you learned
6		of the allegation against Stephen Parker was with Teresa
7		at the prosecutor's office, and in that initial meeting
8		you made a decision that an outside investigation was
9		going to be conducted of Stephen Parker, based on the
10		allegation that he was having a sexual affair with
11		Natalia Garcia.
12	Α.	That is my recollection, yes.
13	Q.	And then, knowing that you had already decided there was
14		going to be an outside investigation, you chose not to
15		put him, Stephen Parker, on administrative leave.
16	Α.	Correct.
17	Q.	How many other times have you requested an outside
18		agency to conduct an investigation of one of your
19		deputies?
20	A.	I believe one other time.
21	Q.	Which time was that?
22	A.	That was that was an incidence with one of my agents,
23		who was the oncall sergeant, took a call in the middle
24		of the night about a home invasion, and he made the
25		decision not to call a deputy out to deal with a
		70

1		potential home invasion where a gun was involved. Yeah.
2	Q.	And so you brought in an outside agency to conduct your
3		internal investigation in that case.
4	Α.	Correct.
5	Q.	Who was the deputy?
6	Α.	Scott Brennan.
7	Q.	And was Scott Brennan placed on administrative leave?
8	A.	He was not.
9	Q.	Why was he not placed on administrative leave?
10	A.	I don't recall exactly what my thinking was going into
11		that. There's a I would call for a call for a lot
12		of speculation on my part. I don't I don't remember
13		why I didn't.
14	Q.	Why did you have an outside agency conduct the internal
15		investigation in that particular matter?
16	Α.	And again I don't remember what my thought process was
17		in regards to that one, so I don't have an answer for
18		you.
19	Q.	What was the policy that he was alleged to have
20		violated?
21	Α.	Well, we had a potential felony case, somebody broke
22		into some home and confronted a homeowner with a gun and
23		allegedly assaulted 'm and fled, and he did not make the
24		decision to call a deputy out to go deal with it,
25		instead opted to wait till the next morning to handle

1		it.
2	Q.	Why does an outside agency need to be brought in to
3		conduct that investigation?
4	A.	Again, I answered that question earlier. I stand by my
5		answer. I don't recall why.
6	Q.	How many detectives did you have in the San Juan County
7		Sheriff's Office?
8	Α.	Two.
9	Q.	Who's the other detective?
10	A.	Lach Buchanan.
11	Q.	And while the investigation of Stephen Parker was
12		pending, was Lach Buchanan a detective at the San Juan
13		County Sheriff's Office?
14	Α.	Yes.
15	Q.	And was he actively investing was he actively
16		investigating cases at the time that Detective Stephen
17		Parker was being investigated?
18	A.	Yes.
19	Q.	At the time Stephen Parker was being investigated, was
20		he still, Stephen Parker, investigating criminal cases?
21	A.	I believe so, but I don't know for certain.
22	Q.	Who assigns cases to the detectives for investigation at
23		your agency?
24	A.	The undersheriff does.
25	Q.	Do you know if he assigned any cases to Detective Parker

1		for investigation while Detective Parker was under
2		investigation?
3	Α.	I don't know.
4	Q.	Did the outside investigation conclude that Stephen
5		Parker was, in fact, having a sexual affair with Natalia
6		Garcia?
7	Α.	I believe so, yes.
8	Q.	Did you review their full investigation report?
9	Α.	I answered that earlier.
10		MR. COOLEY: Yeah.
11	BY N	NR. LEE:
12	Q.	During the pendency of this allegation against Detective
13		Parker, are you aware that Detective Parker accused
14		Natalie Garcia of setting people up?
15	Α.	I heard that, yes.
16	Q.	Who did you hear that from?
17	Α.	I don't recall who I heard it from.
18	Q.	Would you agree that, if your detective tells you or
19		I'll start the question over.
20		Would you agree that, if you learn information
21		that somebody is setting people up, that that is
22		something that the Sheriff's Office should look into?
23		MR. COOLEY: Object to the form. Calls for
24		speculation. It's a hypothetical without facts in
25		evidence.

1		THE WITNESS: Can you repeat the question.
2	BY M	R. LEE:
3	Q.	When you heard that Detective Parker accused Natalia
4		Garcia of setting people up, what action, if any, did
5		you take to determine whether or not his allegation
6		against her was true?
7	A.	I didn't take any action.
8	Q.	Why not?
9	A.	Because it was all being handled by Skagit County, by
10		the SMART team.
11	Q.	Did you ask the Skagit County SMART team to investigate
12		whether or not Natalia Garcia sets people up?
13	Α.	I did not.
14	Q.	When did you hear that Detective Parker accused Natalia
15		Garcia of setting people up?
16	Α.	I don't recall.
17	Q.	Where were you when you heard that Detective Parker
18		accused Natalia Garcia of setting people up?
19	Α.	I don't recall.
20	Q.	What was your reaction to hearing Detective Parker had
21		alleged Natalia Garcia set people up?
22	A.	I don't recall.
23	Q.	Do you believe that, if a deputy in your office has
24		information that a witness sets people up, that there is
25		a obligation to disclose that information to the defense

1		attorneys?
	7	-
2	Α.	I would agree with that.
3	Q.	Are you aware of any disclosure to Dr. Tinner or his
4		defense team that Natalia Garcia sets people up?
5	A.	No.
6	Q.	Are you aware of any disclosure to Dr. Tinner or his
7		criminal defense team that Stephen Parker accused
8		Natalia Garcia of setting people up?
9	Α.	No.
10	Q.	Is it your understanding from your review of the Skagit
11		County report that Detective Parker had sexual
12		encounters with Natalie Garcia on at least five separate
13		occasions?
14		MR. McMAHON: Object to form.
15		THE WITNESS: It's my understanding based on the
16		report that he had sexual encounters with her, yes.
17	BY M	IR. LEE:
18	Q.	Is it your understanding based on the report of Skagit
19		County that some of those sexual encounters between your
20		deputy, Stephen Parker, and Natalia Garcia were not
21		consensual?
22		MR. McMAHON: Object to the form.
23		THE WITNESS: I don't recall.
24	BY M	IR. LEE:
25	Q.	Did you issue a summary of the Skagit County report in

1		which you concluded or I'll say instead of
2		concluded, I'll say reiterated that some of the sexual
3		encounters between Natalia Garcia and Stephen Parker
4		were not consensual?
5	A.	I don't recall.
6	Q.	Is an allegation that one of your deputies had
7		non-consexual intercourse with a witness in a case in
8		which he was investigating the kind of thing that you
9		would forget?
10	A.	No.
11	Q.	Did you have do you have information that
12		Deputy Stephen Parker used county resources to advance
13		his sexual encounters with Natalia Garcia?
14	A.	Yes.
15	Q.	What county resources did Detective Parker use in
16		furtherance of his sexual affair with Natalia Garcia?
17	A.	So some of the ones I'm aware of, he used a Washington
18		State Ferry pass that belonged to the Sheriff's Office.
19		He used a cell phone, used, I believe, his desk phone
20		and desk computer, and maybe the county credit card. I
21		believe the county credit card as well.
22	Q.	What did he use the county credit card for?
23	A.	Well, at minimum, he used it for a hotel room on Lopez
24		Island.
25	Q.	And when you say that Detective Parker used a county
1		95

1 credit card for a hotel room, what you mean specifically 2 is that Detective Parker used a San Juan County Sheriff's Office credit card to obtain a hotel room so 3 4 that he could have sex with Natalia Garcia. Correct? MR. McMAHON: Object to the form of the 5 6 question. 7 Detective Parker used the San Juan THE WITNESS: 8 County Sheriff's Office credit card to obtain a hotel 9 room on Lopez Island. I'm not -- that's as far as I 10 will go with my knowledge of that. 11 BY MR. LEE: To your knowledge, did he have official duties that 12 Ο. 13 compelled him to get a hotel room with the county credit 14 card on that occasion? 15 I don't know. I don't believe so, but I don't know. Α. 16 Did your summary of the Skagit County report conclude --Ο. 17 include a finding that he misused the county credit card to purchase a hotel room so that he could have sex with 18 19 Natalie Garcia? 20 I don't recall exactly what's in my summary. I'd have Α. 21 to go back and look at my summary again. 22 Do you believe it's improper for a sheriff's deputy to 0. 23 use county resources to further an affair with a 24 witness? 25 Α. Yes.

1 Ο. Is it illegal for a sheriff's deputy to use county 2 resources to purchase a hotel room for the purpose of 3 having a sexual encounter with a witness? 4 MR. COOLEY: Object to the form. Calls for a 5 legal conclusion. Calls for speculation. 6 MR. McMAHON: Join. 7 THE WITNESS: I wouldn't be able to answer that. 8 BY MR. LEE: 9 You're a police officer. Right? Q. 10 Α. Correct. 11 You're trained in the Revised Code of the State of Ο. 12 Washington as it relates to the Criminal Code of the 13 State of Washington. Correct? 14 Correct. Α. 15 You're trained in how to investigate a case and 0. 16 establish facts that will reach the probable cause point 17 in a case. Correct? 18 Α. Correct. 19 And you're trained in how to investigate a case, to Ο. 20 build a case that can be proven beyond a reasonable 21 doubt. Correct? 22 Α. Correct. 23 Ο. And you're aware that it is a crime in the state of 24 Washington to take somebody's funds. Correct? 25 Correct. Α.

1 Ο. All right. So did you authorize Detective Parker to use 2 county funds to get a hotel room to have a sexual 3 encounter with Natalie Garcia? 4 Α. I did not. 5 Did any policy or procedure authorize him to use the 0. 6 credit card for that purpose? 7 Α. No. 8 Ο. So would you agree, then, that he had no lawful purpose 9 to use the county's funds to purchase a hotel room for a 10 sexual encounter with Natalia Garcia? 11 MR. McMAHON: Object to the form of the 12 question. Calls for speculation. 13 MR. COOLEY: Join. 14 THE WITNESS: I still stand by cannot answer 15 that question. 16 BY MR. LEE: 17 Have you ever presented a case to a prosecutor because 0. 18 you believe that probable cause of a crime had been 19 established? 20 Α. Yes. 21 Q. You've done that on numerous occasions. 22 Α. Yes. And you've done it for theft cases. 23 Ο. 24 Α. Yes. 25 Q. But as we sit here today, you can't tell me whether or

1		not you think there's probable cause for a crime in this
2		case.
3	A.	Correct.
4	Q.	Okay. Do you think that in such circumstances maybe you
5		should have asked an outside agency to determine whether
6		or not a theft of county funds had occurred?
7	A.	I did.
8	Q.	Specifically a theft of county funds.
9	A.	I asked for an outside agency to investigate the
10		entirety of this case.
11	Q.	Did you in writing ask anyone to investigate theft of
12		county funds?
13	Α.	No.
14	Q.	Did you review the any reports that indicated that
15		prosecutors at any time considered charges of theft of
16		county funds by Stephen Parker?
17	A.	I don't recall.
18	Q.	After you became aware that Natalia Garcia had accused
19		Stephen Parker of having an affair with her, did you
20		ever hear anyone say that Stephen Parker is alleged to
21		have told Natalie Garcia to, quote, fix it, end quote?
22	A.	Yes.
23	Q.	Who told you that Stephen Parker told Natalie Garcia to,
24		quote, fix it?
25	A.	I don't recall.

1 Q. When were you told that Stephen Parker told Natalia 2 Garcia to, quote, fix it? 3 I don't recall. Α. 4 When you learned that Stephen Parker told Natalia Garcia Ο. 5 to fix it, did you take that to mean he was telling 6 Natalia Garcia to say that she did not have a sexual 7 encounter with Stephen Parker? 8 MR. McMAHON: Object to the form of the 9 question. 10 MR. COOLEY: Join. 11 THE WITNESS: I don't recall what I was 12 thinking. 13 BY MR. LEE: 14 Do you believe it's appropriate for somebody who's under Ο. 15 investigation to tell a witness to, quote, fix it, end 16 quote? 17 No. Α. 18 Q. Did you, prior to hearing that Stephen Parker told 19 Natalie Garcia to, quote, fix it, end quote, tell 20 Stephen Parker not to contact Natalia Garcia? 21 Α. Could you repeat that question. 22 Sure. I'll say it a little bit better, hopefully. 0. 23 When you heard that Stephen Parker told Natalia 24 Garcia to, quote, fix it, end quote, was it after you 25 had specifically directed him not to contact her?

1 Α. Yes. 2 Why was he not immediately fired when you learned that Ο. 3 he violated your direction? 4 Stephen Parker was under investigation. We were waiting Α. 5 for the conclusion of the investigation before we made 6 any disciplinary determinations. 7 Did you take any disciplinary action specific to him Ο. telling Natalia Garcia to fix it? 8 9 Α. No. 10 0. Who told you that Stephen Parker pressured Natalie 11 Garcia to recant her allegation of sex between Stephen 12 Parker and Natalia Garcia? 13 MR. McMAHON: Object to the form of the 14 question. 15 THE WITNESS: I don't recall. 16 BY MR. LEE: 17 When did you first learn -- you are aware that he told Ο. 18 her -- I'll start over. 19 Somebody told you that Stephen Parker was pressuring Natalia Garcia to recant her allegation 20 21 against him? 22 MR. COOLEY: Object to the form of the question. 23 Hearsay. Assumes facts not in evidence. 24 THE WITNESS: I had heard that, yes. 25 111

1 BY MR. LEE:

2	Q.	Who did you hear who is it you heard from how do I
3		say this? Who told you that Stephen Parker had
4		pressured Natalie Garcia to recant her allegation
5		regarding a sexual affair between her and Stephen
6		Parker?
7	A.	I don't recall.
8	Q.	When were you told that?
9	A.	I don't recall.
10	Q.	How did you respond to hearing that?
11	Α.	I don't recall.
12	Q.	Were you shocked?
13	Α.	I don't recall.
14	Q.	Is it inappropriate for somebody on administrative leave
15		to tell a witness to recant their allegation, the
16		complaining witness?
17	Α.	Absolutely.
18	Q.	Were you did you hear from anyone that Stephen Parker
19		had offered her money, Natalie Garcia money not to
20		disclose the sexual relationship between her and Stephen
21		Parker?
22	A.	Yes. I believe I heard that.
23	Q.	Are you aware of the crime in Washington known as
24		witness intimidation?
25	A.	Yes.

1	Q.	Are you aware of the crime in Washington known as
2		witness tampering?
3	A.	Yes.
4	Q.	Are you aware of the crime of bribery?
5	Α.	Yes.
6	Q.	Did you specifically request anyone conduct an
7		investigation of Stephen Parker for witness
8		intimidation?
9	A.	No.
10	Q.	Did you request anyone conduct an investigation of
11		Stephen Parker for witness tampering?
12	A.	No.
13	Q.	Did you request anyone conduct a criminal investigation
14		of Stephen Parker for bribery?
15	Α.	No.
16	Q.	Why not?
17	Α.	Those were all-inclusive and wrapped up in the
18		investigation that the SMART team was conducting.
19	Q.	Is it a general law enforcement duty to conduct a fair
20		investigation?
21	A.	Yes.
22	Q.	Do you believe that one of your deputies could conduct a
23		fair investigation in a case where they are having a
24		sexual affair with the complaining witness, alleged
25		victim?
		93

1 A. I don't believe so, no.

2	Q.	Is there any training material that your agency provides
3		to deputies that puts them on notice that they should
4		not have sexual affairs with complaining witnesses or
5		victims?
6	Α.	No.
7	Q.	Why not?
8	Α.	That all falls under our code of conduct, our rule of
9		ethics, the oath that we take, and just, you know, we
10		don't we don't conduct a training that says you won't
11		murder people. We don't conduct training says you won't
12		beat people. There's all kinds of things we don't
13		conduct training on that you just should not need to
14		conduct training on. It's common sense and basic
15		human
16	Q.	Decency?
17	Α.	Decency, yeah.
18	Q.	You don't conduct training on use of force?
19	Α.	We do conduct training on use of force.
20	Q.	And that would be training that says don't beat people.
21		Right?
22	Α.	I suppose so.
23	Q.	Okay. You took an oath to become the sheriff. Is that
24		right?
25	Α.	I did.

1	Q.	Was that oath something you took seriously?
2	Α.	Something I take very seriously.
3	Q.	As we sit here today, you take that oath very seriously?
4	A.	I do.
5	Q.	Is it something that's a guiding principle for you?
6	A.	It is.
7	Q.	Please tell me what your oath of office says.
8	Α.	I can't tell you what my oath of office says.
9	Q.	How is it it's so serious and you can't even tell me
10		what it says?
11	A.	It's a long oath of office that says "I'll uphold the
12		rules and the laws of the State of Washington
13		Constitution and the county I live in," but I can't
14		recite it word for word for you.
15	Q.	Have you ever heard of a case referred to generally as
16		Brady versus Maryland?
17	A.	I have.
18	Q.	What do you know about the case Brady versus Maryland?
19	A.	I know it's the it's a case that deals with the
20		integrity and honesty of an officer and their
21		credibility as a witness.
22	Q.	Did you attend the Washington State police officer
23		academy?
24	Α.	I did.
25	Q.	When did you attend that?

1 Α. 2006. No. Yeah. 2006. 2 And did you receive training on Brady versus Maryland? Q. 3 I believe we did. Α. 4 Does every officer who you hire have to complete the Ο. 5 Washington State Police Academy prior to becoming a 6 sheriff's deputy? 7 Α. No. 8 Ο. Do some of them complete a reserve academy first? 9 Some of them complete a reserve academy. Some of them, Α. 10 if they come from out of state, they complete an 11 equivalency academy, which is a two-week-long academy, 12 if they're prior law enforcement from out of state. 13 Did Stephen Parker complete the Washington State police Q. 14 officer academy? 15 No. Α. 16 Did Stephen Parker complete a reserve academy? Ο. 17 Α. No. 18 Q. Do you have a reserve academy for the San Juan County 19 Sheriff's Office? 20 I do. Α. 21 Who conducts the training for the reserve academy for Q. 22 the San Juan County Sheriff's Office? The reserve academy is put on by Skagit Valley Community 23 Α. 24 College. 25 Q. Who are the instructors for the reserve academy?

1 Α. I don't know. There are a number of them. 2 Can you name some of them? Ο. 3 Α. No. 4 Jerry Dodd, the former chief of police in Mount 5 Vernon, was one. Bill Oversby was the gentleman who 6 conducted the reserve academy, but I believe he's 7 retired now. I don't know who does it currently. 8 Ο. Do you provide any training in the reserve academy? 9 Α. No. 10 Does the reserve academy provide training on the law 0. 11 enforcement obligation to provide exculpatory evidence 12 under Brady versus Maryland? 13 I would assume so. Α. It's the academy that you send potential deputies to. 14 Ο. 15 Correct? 16 Correct. Α. 17 You're not aware whether or not it actually provides Ο. 18 training to your future employees on their obligation to 19 provide exculpatory or disclose exculpatory evidence. 20 I would assume so. It's an accredited Washington State Α. 21 reserve academy accredited through CJTC. They're the 22 ones that guide the training and everything that is 23 required to be a police officer in the state of 24 Washington. So if they're getting the certification 25 through the Washington State Criminal Justice Training

1		Commission, then I am going to assume that they are
2		getting everything that is required. Exactly what is in
3		it, I don't know.
4	Q.	What specific training on the obligation to disclose
5	2.	the law enforcement obligation to disclose exculpatory
6		evidence are you aware of having been provided to
7		
	_	Stephen Parker?
8	A.	I am I don't know.
9	Q.	Does your agency specifically provide training to its
10		deputies on the law enforcement obligation to provide
11		exculpatory evidence?
12	Α.	No.
13	Q.	Do you think that it is important for law enforcement
14		officers to provide and disclose exculpatory evidence in
15		cases they investigate?
16	Α.	Yes.
17	Q.	And you provide no training on that point that you
18		believe is important.
19	A.	We provide the basic law enforcement training, which is
20		a six-month academy through the Law Enforcement Training
21		Commission, and they get all the training that is needed
22		through them.
23	Q.	And that is the academy that was not attended by Stephen
24		Parker.
25	Α.	Stephen Parker attended an equivalency academy. He
		98

1		attended an academy from out of state which is certified
2		or authorized through the State of Washington as an
3		equivalent law enforcement academy.
4	Q.	Do you know what is instructed at the original state
5		where Stephen Parker went to the other state's police
6		academy?
7	A.	I don't.
8	Q.	Did you ever look into that?
9	A.	No.
10	Q.	Do you believe that your officers, your deputies are
11		aware of the obligation to disclose exculpatory evidence
12		in cases they're investigating?
13	A.	Yes.
14	Q.	And on what do you base your opinion that your officers
15		are aware of their obligation to disclose exculpatory
16		evidence in cases that they're investigating?
17	A.	Because that's what you're taught in the police academy.
18	Q.	So you believe Stephen Parker was taught that at some
19		point prior to coming into your employment.
20	Α.	I do.
21	Q.	That obligation to disclose exculpatory evidence
22		includes evidence that could be used to impeach a
23		witness, does it not?
24	A.	Can you repeat that.
25	Q.	The obligation to disclose exculpatory evidence for law

1		enforcement officers includes evidence that could be
2		used to impeach a witness. Correct?
3		MR. COOLEY: Object to the form. Calls for a
4		legal conclusion. It's vague what you mean by
5		impeachment evidence.
6		THE WITNESS: Yeah. I wouldn't know how to
7		answer I don't know how to answer that.
8	BY M	R. LEE:
9	Q.	Do you know what impeachment evidence is?
10	A.	I do.
11	Q.	Okay. How do you know what impeachment evidence is?
12	A.	I know I know through just the being in the
13		profession what impeachment evidence is.
14	Q.	Okay. So impeachment evidence could be something that
15		shows a witness's bias. Right?
16	A.	Uh-huh.
17	Q.	Or it could be evidence that shows a witness is
18		motivated to lie. Right?
19	A.	Correct.
20	Q.	Or it could show be evidence that shows a witness has
21		previously been dishonest. Right?
22	Α.	Correct.
23	Q.	And that's impeachment evidence, and you understand that
24		the law enforcement obligation under Brady versus
25		Maryland includes disclosure of impeachment evidence.

1 Right?

² A. Correct.

3 Okay. And you would agree that, if somebody was a Ο. 4 witness known by law enforcement to set people up, that 5 law enforcement has an obligation to disclose that to 6 the subject of the investigation. Correct? 7 MR. COOLEY: I'm going to object. That calls 8 for a legal conclusion. 9 THE WITNESS: I would agree with that. 10 BY MR. LEE: 11 And you would agree that under this disclosure 0. 12 obligation, if law enforcement was having an affair with 13 the complaining witness or alleged victim in a case, 14 that officer has an obligation to disclose that to the 15 accused as well. Correct? 16 MR. COOLEY: Object to the form. It's a 17 hypothetical without facts in evidence. Calls for a 18 legal conclusion. 19 THE WITNESS: Yeah. I'm not familiar with what 20 a prosecutor or what the prosecution needs to disclose 21 under Brady versus Maryland, so I don't know how to 22 answer that. I wouldn't be able to answer that. 23 BY MR. LEE: 24 Do you think that, if you as sheriff are advised that Ο. 25 one of your deputies is having a sexual affair with a

1		witness, that you don't have an obligation to disclose
2		that to the accused?
3	Α.	That's not what I said.
4	Q.	Do you believe you do in that circumstance have an
5		obligation to disclose that?
6	A.	Yes. I believe I would.
7	Q.	Do you think your deputies understand that they have
8		that same disclosure obligation that we just discussed?
9	Α.	I believe so.
10	Q.	And that's because of their training?
11	Α.	Training, oath of office, code of ethics, yes.
12	Q.	And would that also because of office policy?
13	A.	Yes.
14	Q.	Do you believe that Detective Parker violated the
15		policies and procedures of the San Juan County Sheriff's
16		Office by having an affair with Natalia Garcia?
17		MR. McMAHON: Object to the form of the
18		question. Asked and answered.
19		THE WITNESS: Yes, I do.
20		Excuse me for a second. That sun's coming right
21		in the window in my eye there.
22		THE VIDEOGRAPHER: Let me go off the record.
23		(Discussion held off the record.)
24		THE VIDEOGRAPHER: I'm back on the record.

1 BY MR. LEE:

2	Q.	Did the San Juan County does the San Juan County
3		Sheriff's Office provide regular refresher courses to
4		the deputies?
5	Α.	Yes.
6	Q.	Who conducts the training for those courses?
7	Α.	It's a myriad of people. We send them off island.
8		Generally goes through CJTC-accredited classes or
9		classes at the Criminal Justice Training Commission,
10		even.
11	Q.	Do you ever do training on the island inside the
12		Sheriff's Office?
13	A.	Not generally. Occasionally but not generally.
14	Q.	Do you keep records of who attends what training?
15	A.	Yes.
16	Q.	Do you provide training to your officers on the
17		obligation to disclose exculpatory evidence?
18	A.	No.
19	Q.	Why not?
20	A.	Again, that's just common sense. That's what we do.
21		It's law enforcement.
22	Q.	Was Detective Parker required to attend the same
23		training as all other officers?
24	A.	Yes.
25	Q.	Did he?

1	A.	Well, so everybody takes different training. We don't
2		all train on the exact, same thing.
3		Some people may go to crime scene investigation.
4		Some people may go to accident investigation. We have
5		TASER training. We have firearms training. We have
б		domestic violence training. Some classes, everybody
7		attends. Other classes are individuals.
8	Q.	While Detective Parker was employed at the San Juan
9		County Sheriff's Office, did you have a rules of conduct
10		policy?
11	Α.	Yes.
12	Q.	Was it in writing?
13	Α.	Yes.
14	Q.	Had a copy of that rules of conduct policy and procedure
15		document been provided to Stephen Parker when he became
16		employed with your agency?
17	A.	Yes.
18	Q.	Do you keep a record showing that you provided that to
19		them?
20	A.	Yes.
21	Q.	And do the policies contained in the rules of conduct of
22		the Sheriff's Office prohibit officers from having
23		sexual encounters with witnesses or victims in cases
24		they investigate?
25	Α.	Not directly, no.

1	Q.	Does it generally prohibit that by some kind of
2		catch-all doctrine that's in the policy manual?
3	A.	Yes.
4	Q.	What policy would that be? What would the catch-all
5		doctrine be?
6	A.	I don't know.
7	Q.	When was the rules of conduct of the Sheriff's Office
8		put into place?
9	A.	I don't know.
10	Q.	Was it put into place prior to you becoming a deputy at
11		the San Juan County Sheriff's Office?
12	A.	Yes.
13	Q.	When you became a deputy at the San Juan County
14		Sheriff's Office, were you provided a copy of the rules
15		of conduct of the Sheriff's Office?
16	A.	Yes.
17	Q.	Did you read the rules of conduct of the Sheriff's
18		Office in its entirety?
19	A.	Probably.
20	Q.	When was is the rules of conduct of the Sheriff's
21		Office still in place?
22	A.	I've modified the rules of conduct and the code of
23		conduct.
24	Q.	When did this modification occur?
25	A.	2015.

1	Q.	Was that before or after the alleged affair between
2		Stephen Parker and Natalia Garcia?
3	A.	It was before.
4	Q.	And how did you modify it?
5	A.	I changed the wording. I added basically a code of
6		conduct and a ethics mission, vision, and value
7		statement to it.
8	Q.	What wording did you change?
9	A.	I don't recall. I changed most all of it.
10	Q.	So you changed most all of the
11	A.	Yeah. I put my own code of conduct, ethics, mission,
12		vision, values in place.
13	Q.	And you said you had a mission statement that you put in
14		there?
15	Α.	I did.
16	Q.	And that's the mission statement for the San Juan County
17		Sheriff's Office?
18	A.	Correct.
19	Q.	And that would be the guiding principle for all law
20		enforcement officers in the San Juan County Sheriff's
21		Office?
22	Α.	It would be one of them.
23	Q.	Okay. It's the statement of what their mission is as
24		deputies. Right?
25	A.	Correct.

1	Q.	And you might have even posted that on the wall
2		somewhere so everyone could read the mission statement
3		every day when they come into the Sheriff's Office.
4		Right?
5	A.	Right.
6	Q.	So is the mission statement of your office currently
7		posted up on the wall in the Sheriff's Office so
8		everyone can see it?
9	Α.	I don't believe it is right now.
10	Q.	Was it for a period of time?
11	Α.	It was.
12	Q.	What period of time?
13	Α.	I don't recall.
14	Q.	What does your mission statement say?
15	Α.	I don't recall it word for word.
16	Q.	What is the mission of the San Juan County Sheriff's
17		Office?
18	Α.	It's to preserve the the mission of the San Juan
19		County Sheriff's Office is to protect, serve the
20		citizens of San Juan County.
21	Q.	That's it? That's the one-sentence mission statement?
22	Α.	That's what it's that's what we're changing it to.
23		What it was at the time, I don't I don't recall the
24		mission statement word for word, which is what's
25		predicated the change in our mission statement.
		107

1	Q.	When you changed the rules of conduct for the Sheriff's
2		Office in 2015, did you republish that rules of
3		conduct is it a manual?
4	Α.	Yes.
5	Q.	Okay. Did you reprovide that manual to every member of
6		your agency?
7	Α.	I did not.
8	Q.	Did you make it available to every member of your
9		agency?
10	Α.	Every member of our agency gets a copy of the manual
11		when they go through their field training officer
12		program.
13		When you're hired you go through a field
14		training officer period where you're riding with an
15		experienced officer. Part of the FTO program and the
16		checkoff is to get a copy of the manual and to go
17		through it with your FTO.
18		So I provided copies of the changes that were
19		made and in the mission, vision the mission, vision,
20		and value statement along with the code of ethics and
21		their oath of office. When they're sworn in, they also
22		are read the mission, vision, values, and the code of
23		ethics at that time. It's all signed at that time and
24		then put into the front of their employee file.
25		So the members of the Sheriff's Office had a

1		copy of that manual already.
2	Q.	All right. But then you changed the manual.
3	Α.	I changed parts of it.
4	Q.	All right. When you changed parts of the manual, did
5		you provide copies of the changes
б	A.	Yes.
7	Q.	to every deputy and then provide a document in their
8		employee file showing that you had provided that to
9		them?
10	A.	I did.
11	Q.	And that would include Stephen Parker.
12	A.	Yes.
13	Q.	So at the time of the alleged affair between Natalia
14		Garcia and Detective Parker, Detective Parker had
15		already been put on notice about the policies in the
16		Sheriff's Office.
17	A.	Yes.
18	Q.	And those policies generally tell you: Don't have sex
19		with witnesses in cases you're investigating.
20	A.	In not so many words. Yes.
21	Q.	Did, to your knowledge, Detective Parker disclose to
22		anyone at the San Juan County Sheriff's Office that he
23		was having an affair with Natalia Garcia?
24	A.	No.
25	Q.	So he kept that information secret from everyone at the

1 San Juan County Sheriff's Office. 2 Α. Yes. 3 MR. McMAHON: Object to the form of the 4 question. 5 BY MR. LEE: б Q. Do you know if he advised anyone at the San Juan County 7 Prosecuting Attorney's Office that he was having an affair with Natalia Garcia? 8 9 Α. I don't know. Was it proper for Stephen Parker to have an affair with 10 Q. Natalia Garcia and not disclose that information? 11 12 MR. McMAHON: Object to the form of the 13 question. 14 MR. COOLEY: Has been asked and answered. 15 THE WITNESS: Yeah. I believe I've already 16 answered that question. I'm going to stand by it. 17 BY MR. LEE: 18 Q. Okay. Are you aware that Judge Eaton -- you know who 19 Judge Eaton is? I do. 20 Α. 21 Who is Judge Eaton? Q. 22 He was the Superior Court judge for San Juan County. Α. 23 And how long has he been the Superior Court judge? Q. 24 Α. He's retired now. I don't -- I don't know how long he 25 was Superior Court judge.

1	Q.	Was he a Superior Court judge for the entire time that
2		you were a sheriff's deputy or the elected sheriff prior
3		to his retirement?
4	Α.	I believe so, yes.
5	Q.	And are you aware that he used the phrase, quote,
6		miscarriage of justice, end quote, in relation to State
7		of Washington versus Gerald Tinner?
8	A.	I don't know that for sure.
9	Q.	Did you attend the court hearing, the final court
10		hearing in State of Washington versus Gerald Tinner?
11	Α.	I did not.
12		MR. COOLEY: Sorry. Phone was turned off, too.
13	BY I	MR. LEE:
14	Q.	Detective Parker started his employment in San Juan
15		County in January of 2015?
16	A.	Yes.
17	Q.	Who hired him?
18	A.	Sheriff Rob Nou.
19	Q.	And did you work for Sheriff Nou?
20	Α.	I did.
21	Q.	When did you take your oath of office as Sheriff?
22	Α.	I took the official oath of office, I believe, the 31st
23		of December and then the ceremonial oath of office on,
24		like, the 4th of January.
25	Q.	When did your tenure as let me start the question

1		over.
2		When did you officially become Sheriff of San
3		Juan County?
4	A.	That would have been January 1st of 2015.
5	Q.	And what day did Stephen Parker start employment?
6	A.	I don't recall.
7	Q.	Was it January 1st of 2015 or after?
8	A.	I don't I don't recall.
9	Q.	Prior to you taking office, were you aware that Stephen
10		Parker had been offered employment at San Juan County
11		Sheriff's Office?
12	A.	Yes.
13	Q.	Who advised you that Stephen Parker had been offered
14		employment at the San Juan County Sheriff's Office?
15	A.	Sheriff Rob Nou.
16	Q.	Now, deputies at the San Juan County Sheriff's Office
17		are appointees of the sheriff. Correct?
18	A.	They're hired by the sheriff. Correct.
19	Q.	No. No. They're appointees. They are appointed and
20		deputized by the Sheriff. Correct?
21	A.	Correct.
22	Q.	You have the power, as the elected sheriff, to decide
23		who you're going to deputize and who you're not going to
24		deputize. Correct?
25	Α.	Correct.

1	Q.	You have the authority to hire and fire deputies based
2		on what you want to set as the who you're going to
3		employ. Right?
4	A.	Correct.
5	Q.	Did you swear in Stephen Parker as a deputy at the San
6		Juan County Sheriff's Office?
7	Α.	Yes.
8	Q.	Did you do that before or after you became sheriff?
9	Α.	Would have been after I've been sheriff.
10	Q.	Okay. So Stephen Parker was deputized and appointed as
11		a sheriff's deputy by you. Correct?
12	A.	Correct.
13	Q.	Did anyone force you to hire Stephen Parker?
14	A.	No.
15	Q.	Did anyone force you to deputize Stephen Parker?
16	A.	No.
17		I swore in all the deputies after I was elected
18		sheriff.
19	Q.	And that's because, when one sheriff ends their office,
20		all of their deputy appointments expire.
21	A.	Correct.
22	Q.	And in order for them to have authority, you have to
23		select who you're going to deputize. Right?
24	A.	Correct.
25		MR. LEE: I've got, like, eight more pages. I
		113

1 don't know when you want to take lunch. I'm happy to 2 keep going, or I'm happy to take lunch. MR. COOLEY: Why don't we go 15 more minutes, 3 4 and we'll take a 30-minute or 40-minute lunch break and 5 then -- that sound good? 6 MR. LEE: Yeah. 7 MR. COOLEY: Okay. 2	Α.	So we have a detective in the detectives' office that
3		goes through a personal history statement and then
4		conducts reference checks, phone calls, a whole bunch of
5		things they go through and do in a background check.
6		It's a very in-depth and detailed process.
7	Q.	What else does it include?
8	Α.	Includes a whole bunch of stuff.
9	Q.	Like what?
10	Α.	Like criminal records checks, credit checks, personal
11		reference checks, contacting personal employers. There
12		really is no limit or end to what a background check is
13		or could be.
14	Q.	Does it include a polygraph?
15	Α.	It does.
16	Q.	Do you still have Stephen Parker's polygraph in his
17		file?
18	Α.	I believe so.
19	Q.	Have you reviewed it in the last 24 months?
20	Α.	I don't believe so.
21	Q.	Who administered the polygraph?
22	Α.	I don't recall.
23	Q.	Is any deputy at the San Juan County Sheriff's Office a
24		trained polygrapher?
25	A.	No.

1	Q.	Who do you send potential employees to for their
2		preemployment polygraph?
3	Α.	A gentleman by the name of Rob Deikman out of Mount
4		Vernon, I believe.
5	Q.	Prior to hiring Detective Parker and employing him at
6		the San Juan County Sheriff's Office, did you review the
7		results of his polygraph examination personally?
8	Α.	Yes. I reviewed everything.
9	Q.	What else did you review?
10	Α.	The background check.
11	Q.	Was that presented to you in a packet: Here's the
12		background check, and it's got everything in it?
13	Α.	Yes. It's his personnel folder.
14	Q.	Prior to swearing in Detective Parker, did anyone warn
15		you that you should not hire Stephen Parker?
16	Α.	Yes.
17	Q.	Who warned you that you should not hire Stephen Parker
18		prior to you hiring him?
19	Α.	Deputy Jeff Asher.
20	Q.	How did Deputy Asher warn you that you should not hire
21		Stephen Parker?
22	Α.	Deputy Asher called me at home one night around the
23		middle of December. I don't know the exact date.
24		Called me on my cell phone, called me at home.
25	Q.	And what did he say to you on that phone call?

1 Α. So Deputy Asher called and -- this is not a verbatim 2 transcription of what the call was, but it's an 3 approximation and a generalization. 4 He called and said something to the effect of, 5 you know, we've got bad news. 6 I said: What's -- what's going on? 7 He said: This -- this Parker quy is bad, bad 8 news. He's -- he's bad news. And I said: Well, what do you mean? 9 10 And he said that he was contacted by a guy that 11 he hadn't seen in 25 years. It was a guy that he worked 12 with in the parks service, because Deputy Asher used to 13 work for State Parks. State Parks, I believe, State 14 Parks or maybe the Forest Service. One of the two. 15 He said that he was contacted by this guy, just 16 reached out to him, heard that Parker was coming here, 17 and he said that Parker tended to make things up; he hid 18 evidence; he changed stories; he intimidated people. He 19 gave a very grandiose story of misconduct on Parker's 20 behalf, said that Parker, you know, hid evidence. He 21 would change people's statements to suit his needs, to 22 fit his case. 23 And I said: Man, how -- how did he get past the 24 background check on this? And he said: Well, Brent doesn't ask the right 25 117 questions.

1

2 So I asked him: All right. Who told you this? 3 He said: It's a friend of mine. I haven't seen 4 him in a long time. He's a judge. He's in charge of --5 I think he said something about the ethics committee, 6 he's a judge in charge of ethics. 7 And I kept pressing him, asking him for "Who did 8 you speak with?" He wouldn't tell me who he spoke with, 9 kept kind of circling around and coming back to other 10 things. 11 And I said -- at that point I have a history with Jeff. We all have a history with Jeff. And I 12 13 realized this is probably one of those Jeff things. 14 So I said: Well, okay. I don't know what else 15 we can do. He had a background check. He passed a 16 polygraph and a psych. I don't know how all this could 17 get past it. 18 I said: You know, probably the one person that 19 maybe we haven't spoken with in this investigation was 20 maybe the prosecutor in Montana. 21 And I finally told him, I said: Well, I'll have 22 Randy -- I'll see if Randy will reach out to the 23 prosecutor in Montana and see if there's anything. 24 He said: Yeah, yeah, that's a good idea. 25 Great.

1 And we hung up the phone. That was the end of 2 that. End of that. That would seem to be a very serious warning about a 3 Q. 4 deputy you were about to hire. Would you agree? 5 I would agree. Α. 6 Ο. Did you contact the deputy who completed the background 7 investigation on Stephen Parker and confront him with 8 this information that you had just been provided from 9 Deputy Asher? 10 I did. Α. 11 When did you do that? Ο. 12 Α. I don't recall when it was. I might have called him 13 that night, or it might have been the next morning in 14 the office. 15 Did you ask that deputy to follow up and investigate the Q. 16 information that you had been provided by Asher? 17 That deputy was my undersheriff, who had -- was Α. previously our lead detective who did the background 18 19 check. He didn't believe that that was accurate. 20 And I told him that -- we talked about who else 21 we could have contacted. 22 And he said: We've contacted everybody, and 23 nobody had anything bad to say about him. 24 Went back through his employee file. I told him 25 I was going to ask Randy, the prosecuting -- the elected

1 prosecuting attorney, to reach out to the elected 2 prosecutor in Chouteau County, Montana, and see if they 3 had any information. 4 And he agreed that was a good idea. 5 Did you ask the undersheriff to reach out to that county 0. 6 in Montana about these allegations from Asher and find 7 out if there was any information they could obtain? 8 Α. No. He had already reached out to them previously. 9 Did he document that in writing anywhere? Q. 10 Α. That he had reached out to them previously? 11 Uh-huh. Ο. 12 Α. Yeah. That's part of the background check. 13 Did you ever have the undersheriff speak with Asher Ο. 14 directly so Asher could provide points or contact points 15 for this information? 16 We both spoke with Asher. Α. 17 When was that? Ο. 18 Α. I don't recall. It was maybe a month later. 19 We had to talk to him about -- Deputy Asher was 20 going around saying some disparaging things about 21 Detective Parker to the other employees, and it was 22 getting back to -- it was getting back to Parker. 23 And Parker said -- you know, basically was 24 saying this was harassment and it needs to stop. 25 So we pulled Jeff aside, sat down and talked to

1 him, said: Hey, you need to stop saying this. This is 2 harassment. He's feeling harassed. If you have any 3 information, you need to tell us. 4 And he didn't have any information, wouldn't 5 tell us any -- give us any information. 6 Q. So that was after Deputy Parker had been hired. 7 Correct? 8 Α. Yes. 9 So after Detective Parker had been hired, Deputy Asher Q. 10 continued to say inside the agency that Detective Parker 11 should not have been hired because of these red flags. 12 Right? 13 I don't know exactly what he was saying, but he was --Α. 14 he was saying things about Parker, yes. 15 Things about his prior employment? Q. 16 Α. I'm not sure. 17 Well, you told him to stop saying something. Ο. What was 18 it you told him --19 I told him to stop talking bad about him behind his Α. back. 20 21 Q. What was he saying bad about him? 22 I don't recall. I know we had a complaint from Parker Α. 23 about Asher, and we talked to Asher about it. 24 Was that complaint in writing? Q. 25 From Parker? No. Α.

1	Q.	Was anything in relationship to your conversation with
2		Asher about the complaint by Parker ever reduced to
3		writing?
4	Α.	No.
5	Q.	So let me make sure I understand this. You were warned
б		not to hire Stephen Parker by Deputy Asher.
7	A.	Yes.
8	Q.	And then you hired him anyhow. Despite the warnings
9		from Deputy Asher you hired Stephen Parker. Correct?
10	A.	Rob Nou, Sheriff Nou hired Stephen Parker. I just kept
11		him on.
12	Q.	Well, no. You appointed him.
13	A.	Okay. I did not hire Stephen Parker. Rob Nou hired
14		Stephen Parker.
15		I appointed him. Correct. I swore him in under
16		my oath of office, yes.
17	Q.	What day was his first day of employment?
18		MR. COOLEY: Objection. Asked and answered.
19		THE WITNESS: Yeah. I don't recall.
20	BY M	R. LEE:
21	Q.	You swore him as a deputy, Stephen Parker, despite the
22		warnings from Jeff Asher.
23	A.	Yes.
24	Q.	And then, when Jeff Asher told other deputies his
25		concerns about Stephen Parker, you and the undersheriff

1		told Jeff Asher to stop saying things about Stephen
2		Parker.
3	A.	Yes. We told him that, if he has concerns with Stephen
4		Parker or information that we could use or information
5		we could follow up on, that he needed to provide them to
6		us, not to the other employees in the office.
7	Q.	Was it a policy violation for Jeff Asher to tell other
8		officers about his concerns as it relates to Stephen
9		Parker?
10	A.	I don't know that it was a policy violation, but it was
11		creating, I guess, a for lack of a better term, a
12		hostile work environment for Detective Parker.
13	Q.	Was there anything that you know that Jeff Asher said
14		about Stephen Parker that was not, in fact, true?
15	A.	I don't know that anything that Detective Asher said
16		about Stephen Parker was true.
17	Q.	No. I said was not true. Is there anything you know
18		that Stephen that Asher said about Parker that was
19		not, in fact, true?
20	A.	Is there anything I know Stephen Parker said or that
21		Asher said that was not true? I don't know.
22	Q.	So you had no basis to know or believe that anything
23		Asher said was false; yet you told him to stop saying
24		it.
25	Α.	Correct.

1	Q.	Is it common for you to tell deputies to stop saying
2		things when you have no idea whether they're true or
3		false?
4	A.	If my deputy has an issue with another deputy and they
5		have a complaint, they need to bring it to either
б		myself, the undersheriff, or their sergeant, not
7		continue to spread it around the office amongst
8		employees.
9	Q.	Would you consider the warning from Jeff Asher in
10		relation to the appointment of Stephen Parker a red
11		flag?
12	Α.	That depends.
13	Q.	On what?
14	Α.	Whether I felt Jeff Asher's allegations were credible or
15		not.
16	Q.	How many deputies do you have working for you?
17	Α.	I've answered that earlier. I believe it's 29.
18	Q.	Do you appoint deputies that you do not believe are
19		credible individuals?
20	Α.	No.
21	Q.	You appointed Jeff Asher. Right?
22	Α.	Yes.
23	Q.	Jeff Asher is a credible individual, is he not?
24		MR. McMAHON: Object to the form.
25		MR. COOLEY: Join.
		124

1 THE WITNESS: Not -- I don't have an answer for 2 that. 3 BY MR. LEE: 4 Do you believe that Jeff Asher is a credible person? Ο. 5 Α. No. 6 Ο. So you employ a sheriff's deputy right now that you 7 personally don't believe is credible. 8 MR. COOLEY: Object to the form. That's -misstates the record. 9 10 THE WITNESS: Yes. Jeff Asher is no longer 11 working for the Sheriff's Office. And, no, I do not believe he is credible. 12 13 BY MR. LEE: Did you believe he was credible at the time that you 14 Ο. 15 appointed him to be a deputy in your sheriff's office? 16 Α. No. 17 Why did you appoint a deputy that you did not believe Ο. 18 was a credible person? 19 Because there's laws; there is a guild contract; there's Α. 20 union to follow. I appoint them under my oath of 21 office, but I don't have the right to just terminate 22 people because I don't want them working for me. 23 Ο. What law compelled you to appoint Jeff Asher? 2.4 I don't know. Α. 25 MR. COOLEY: Calls for a legal conclusion.

1		THE WITNESS: Yeah. I don't know the law.
2	BYN	/R. LEE:
3	Q.	Well, you're saying that there was a law that made you
4		have to appoint him.
5	Α.	Yeah.
6	Q.	Why did you appoint him if you didn't believe he was
7		credible?
8	A.	Because I had no choice. I had to appoint him.
9	Q.	Why?
10	A.	Because he was already an employee of the Sheriff's
11		Office. Again, I can't just go through and fire people
12		at will for no cause.
13	Q.	Do you remember a moment ago when we talked about that,
14		when one sheriff leaves, all the deputies' appointments
15		expire?
16	A.	I do.
17	Q.	So his appointment, Jeff Asher's, expired upon the
18		completion of the sheriff you replaced. Correct?
19	A.	No. His his oath of office under the previous
20		sheriff expired.
21	Q.	So he was no longer a sheriff's deputy until you
22		appointed him.
23	A.	That's not
24		MR. COOLEY: Object to form. Yeah.
25		THE WITNESS: I don't believe that's true.
		126

1 BY MR. LEE: 2 Are there any other deputies that you have employed that Ο. 3 you believe are not credible? 4 Α. Yes. 5 What deputies would those be? 0. б Α. I don't --7 MR. COOLEY: Yeah. I'm going to object to the 8 form. 9 MR. POWER: On what basis do you object to the 10 form? 11 MR. COOLEY: Well, you're asking him to defame 12 people on the record. I think I'm penciling this 13 through. 8	Q.	So if you believe an officer has integrity issues, you
9		could fire them for that?
10	Α.	I could begin the documentation process, yes.
11	Q.	Are there any other officers I believe your earlier
12		answer were there were multiple officers that you
13		believed were not credible.
14	Α.	Well, there were two officers that I believe were not
15		credible.
16	Q.	Okay. Aside from the one you just mentioned and Deputy
17		Asher, who else?
18	Α.	That's it.
19	Q.	There are no other officers that you have that are not
20		credible?
21	Α.	I don't believe so, no.
22	Q.	Have you ever documented that Jeff Asher was not
23		credible?
24	Α.	We were beginning that process, yes.
25	Q.	What does that mean when you say you were beginning that

18		documentation in his employee file that suggested he was

20	A.	Yes.
21	Q.	What was that?
22	Α.	I have to go back to his file and look.
23	Q.	When you appointed Jeff Asher as a deputy for your
24		office, did you believe that he was not credible?
25	Α.	Yes.

1	Q.	And you have history, you said, with Jeff Asher?
2	Α.	Yes. We worked together for approximately eight or nine
3		years.
4	Q.	And what did you mean when you said you have history
5		with Jeff?
6	Α.	Jeff Asher is kind of a conspiracy theorist within the
7		office, always believed that everybody was out to get
8		him and that everybody was doing him wrong. For my
9		entire time there I had heard that, over and over so
10	Q.	Did you believe he was dishonest?
11	Α.	Yes.
12	Q.	When did you begin to believe that Jeff Asher was a
13		dishonest person?
14	Α.	I believe Jeff Asher was dishonest in certain
15		circumstances and honest in other ones.
16		Again, Jeff had a way of making things into much
17		bigger issues than they really were. On calls, in
18		cases. And I've seen that pretty much my entire career
19		with him.
20	Q.	My question was: When did you begin to believe that
21		Jeff Asher was dishonest?
22	A.	I guess I would say probably sometime around 2008 would
23		be a guess.
24	Q.	So prior to becoming sheriff you believed Jeff Asher was
25		a dishonest sheriff's deputy?

1	A.	I believe Jeff Asher had issues and had problems.
2	Q.	Okay. Prior to becoming sheriff, you believed he was
3		dishonest?
4	Α.	I believed Jeff Asher prior to becoming sheriff, I
5		believed Jeff Asher had issues and I believed he had
6		problems. And some of those circled around honesty;
7		some of those circled around his paranoia.
8	Q.	Okay. So you said that in 2008 you believed that Jeff
9		Asher was dishonest, and that was before you appointed
10		him as a sheriff deputy. Correct?
11	Α.	Correct.
12	Q.	So at the time that you appointed Jeff Asher as a
13		sheriff's deputy to patrol with a badge and a gun in
14		your county, you believed he was dishonest.
15		MR. COOLEY: Object to form. It's been asked
16		and answered.
17		THE WITNESS: Yes. I answered that question.
18		Stand by my answer.
19	BY M	R. LEE:
20	Q.	Do you think it's appropriate for a county sheriff to
21		employ a deputy that the sheriff personally believes is
22		dishonest?
23		MR. COOLEY: Okay. Hold on. I'm going to
24		object to the form. It's vague what you mean by
25		"employee."

At the time, yes. 22 Would you say that Jeff Asher had a reputation for 0. 23 dishonesty inside the community? 24 Yes. Α. 25 Did you disclose Jeff Asher's reputation for dishonesty Q.

1 to the defense attorneys in the case -- cases that Jeff 2 Asher investigated? 3 Α. No. 4 Do you believe that defendants in cases investigated by Ο. 5 an officer have a right under Brady versus Maryland to 6 know whether or not the officer who investigated them 7 has a reputation for dishonesty, according to the county sheriff? 8 9 MR. COOLEY: Object to form. Calls for a legal 10 conclusion. 11 THE WITNESS: Yeah. I don't know how to answer 12 I don't have an answer for that. that. 13 BY MR. LEE: 14 Do you believe that people accused of a crime by Jeff Ο. 15 Asher have a right to know that you as the county 16 sheriff believed that he was dishonest and had a 17 reputation for dishonesty? 18 Α. And I answered that question. 19 No, you didn't. Ο. T did. 20 Α. 21 What was the answer? Yes or no? 0. 22 I don't know how to answer it. Α. Okay. Did Jeff Asher --23 Ο. 24 MR. LEE: Can we look in the record to see if I 25 got an answer to that question? I don't think I ever

1 got an answer, and I want an answer to that question. 2 THE COURT REPORTER: Which question? 3 MR. McMAHON: It was after the objection, I 4 think. 5 It was the last question I asked. MR. LEE: 6 (Record read.) 7 MR. LEE: I'm sorry. The question before that. 8 (Record read.) 9 MR. LEE: The one before that, the substantive 10 one. 11 (Record read.) 12 BY MR. LEE: 13 No. You never answered that question. What's the Ο. 14 answer? 15 MR. COOLEY: Object to the form. Asked and 16 answered. 17 THE WITNESS: Okay. б	Α.	I've already answered the question.
7	Q.	No, you haven't.
8	Α.	I have answered the question. I stand by my answer.
9	Q.	Did Jeff Asher run against you for sheriff?
10	Α.	He did.
11	Q.	Did he run for sheriff prior to you being elected for
12		sheriff?
13	Α.	I believe so.
14	Q.	Did he run in the same race that you ran for sheriff?
15	Α.	No.
16	Q.	So when you became sheriff, did you view him as somebody
17		who might be a political challenger to you?
18	Α.	No.
19	Q.	Had you ever heard anyone suggest that he was going to
20		run against you in the 2018 election?
21	Α.	No.
22	Q.	Is that the election where he ran against you?
23	Α.	Yes.
24	Q.	Did prior to you appointing Stephen Parker as a
25		sheriff's deputy, did Jeff Asher tell you that Stephen
		107

1		Parker was a, quote, bad apple, end quote?
2	Α.	I don't know if those were the exact words he used.
3	Q.	Did he say something similar to bad apple in reference
4		to Stephen Parker?
5	A.	Said something similar to that.
6	Q.	Did you talk to somebody at the Pentagon about Stephen
7		Parker?
8	A.	I did not, no.
9	Q.	Who did?
10	A.	It would have been my undersheriff.
11	Q.	Who at the Pentagon did he speak to?
12	A.	I don't know.
13	Q.	Is there something in writing documenting who from the
14		Pentagon they spoke to?
15	Α.	I don't know.
16	Q.	What was Stephen Parker's military background before he
17		was hired?
18	Α.	He was in the Air Force, U.S. Air Force, as a criminal
19		investigator.
20	Q.	And you believe there were people at the Pentagon who
21		were character references for Stephen Parker?
22	Α.	That's what I was told.
23	Q.	But you don't have any firsthand knowledge of that?
24	Α.	I don't have it in front of me, no.
25	Q.	Do you regret not following up on the allegations

1		against Stephen Parker by Jeff Asher prior to appointing
2		Stephen Parker a deputy?
3	A.	No. I did follow up on them.
4	Q.	You personally followed up on them?
5	A.	I did.
6	Q.	And is that by sending an email to Randy Gaylord?
7	A.	That is correct.
8	Q.	Did Randy Gaylord respond to your email?
9	A.	He did.
10	Q.	In writing?
11	A.	Yes. I believe so.
12	Q.	And what did he say?
13	A.	He said it would be a good good task for Emma
14		Scanlan, his then chief deputy prosecutor, to handle.
15	Q.	And did Emma Scanlan communicate with you about Stephen
16		Parker prior to you appointing Stephen Parker a deputy
17		in your sheriff's office?
18	A.	I don't know if it was prior, but we did speak about it,
19		yes.
20	Q.	When?
21	A.	I don't know.
22	Q.	Where?
23	A.	I don't know.
24	Q.	What did she say?
25	A.	It's my recollection that she said she contacted

1		Chouteau County and that they had nothing poor or	
2		negative to say about him.	
3	Q.	Who did she say she spoke to?	
4	Α.	I don't recall.	
5	Q.	Did she put anything in writing to you?	
б	Α.	She did not.	
7	Q.	Did you ask her to put anything in writing?	
8	A.	I did not.	
9	Q.	I'm going to hand you Exhibit 1. Please review	
10		Exhibit 1.	
11	Α.	Okay.	
12	Q.	Is this an email from you?	
13	Α.	It appears to be, yes.	
14	Q.	Do you have any reason to believe it's not?	
15	Α.	No.	
16	Q.	And this was sent by you in December of 2014?	
17	Α.	Yes.	
18	Q.	Now, you were not yet the sheriff at that time?	
19	Α.	Correct.	
20	Q.	Do you have access to your work email on your home	
21		computer?	
22	Α.	I do not.

2	Q.	How would you send an email from home?
3	Α.	I have a work computer.
4	Q.	Is that a mobile, like, laptop computer?
5	Α.	Yes.
6	Q.	And does that go in your patrol car?
7	A.	Yes.
8	Q.	So you were at home, and that's how you used it?
9	A.	I am not sure where I was when I sent this email.
10	Q.	Did you ever receive a response to this particular email
11		from Randy Gaylord?
12	Α.	I believe so.
13	Q.	What did his response say?
14	Α.	I answered that already.
15	Q.	Okay. I think that's correct.
16		Did you contact anyone at the PA in Shittua
17		County?
18	Α.	Chouteau County.
19		I did not.
20	Q.	Why didn't you contact somebody in Chou
21		How do you pronounce it?
22		MR. POWER: Chouteau.
23		MR. LEE: Chouteau County.
24		MR. McMAHON: Chouteau.
25		MR. LEE: Chouteau?
		140

1 MR. McMAHON: Yeah. 2 I decided to ask Randy to contact THE WITNESS: 3 them, thinking that -- my thinking was that the 4 prosecutor in Chouteau County might be -- talk more 5 candidly and openly to a fellow elected prosecutor than 6 he would, say, a sheriff or potential employer. 7 BY MR. LEE: 8 After Detective Parker's relationship or alleged Ο. 9 relationship with Miss Garcia came to light, did you 10 publicly deny there had been any warning signs which would have indicated that Detective Parker was a 11 12 problem? 13 I believe so. I don't know if I worded it in that Α. 14 many -- in those words, but, yes. 15 Q. Please go back to Exhibit 1 and read the second 16 paragraph out loud. 17 Α. Jeff came to me with a pretty grandiose story of lies, 18 changing statements, hiding evidence, destroying 19 evidence, fabricating victim statements, and other 20 issues regarding Stephen Parker. 9		false.
10	Α.	I did not receive any credible warning signs.
11	Q.	You would agree that your public statement about not
12		receiving any warning signs was false. I did not ask
13		about credibility.
14		MR. COOLEY: Object. It's been asked and
15		answered.
16	BY M	R. LEE:
17	Q.	Well, your answer was non-responsive. You included
18		credible. Your public statement was not whether or not
19		you said you received no credible warnings. You said
20		you received no warnings.
21		MR. COOLEY: Hold on.
22		Objection. It's been asked and answered.
23		THE WITNESS: Okay. I've answered the question.
24		I stand by my answer.
25	///	

1 BY MR. LEE:

2 No. You haven't answered the question. Please answer Ο. 3 the question. 4 MR. COOLEY: You don't like the answer, and your 5 remedy is with Judge Pechman. It's not to just ask it 6 over and over, because he's not going to change his 7 answer. 8 MR. POWER: With all due respect, the witness 9 was changing the actual question. 10 MR. COOLEY: Yeah. With all due respect, there 11 will be one attorney per party on the record in a 12 deposition in federal court. We will not have tag 13 teaming. 14 BY MR. LEE: 15 Would you agree that what Deputy Asher told you prior to 0. 16 the appointment of Stephen Parker, if true, was an 17 indication that Stephen Parker might violate somebody's 18 rights? 19 MR. COOLEY: Object to the form. Calls for 20 speculation. It's hypothetical without facts in 21 evidence. 22 THE WITNESS: Yeah. Again, as I said earlier, 23 I'm not going to answer to a hypothetical situation that 24 didn't happen. 25 111

1 BY MR. LEE: 2 But nobody's instructed you not to answer. So please Ο. 3 answer the question. 4 Α. I did answer. I'm not going to speculate on a 5 hypothetical question. 6 Q. I'm asking you to speculate. 7 Α. I'm not going to. 8 Ο. So you're refusing to answer the question. 9 I am. Α. 10 When you made that public statement about not Ο. Okay. 11 having any warnings about Stephen Parker, was that 12 during an election year for you? 13 I don't believe so. Α. 14 What year was it in? Q. 15 I don't recall. Α. 16 Do you believe you have an obligation to be truthful to Ο. 17 the San Juan County Council? 18 I do. Α. 19 Ο. Do you believe it's a crime to provide false information 20 to the San Juan County Council during a public hearing? 21 MR. COOLEY: Object to the form. Calls for a 22 legal conclusion. 23 THE WITNESS: Yeah. I don't have an answer for 24 that. 25 111

1 BY MR. LEE:

2	Q.	Do you believe it's legal to lie or provide false
3		information to a public servant?
4		MR. COOLEY: Same objection. And it's compound.
5		THE WITNESS: Yeah. I I'm not going to
6		speculate on that.
7	BY MI	R. LEE:
8	Q.	Have you in your time as a police officer ever reviewed
9		the Revised Code of Washington that makes it a crime to
10		provide false information to a public servant?
11	A.	I don't know.
12	Q.	You don't know if you're aware that it's a crime in the
13		state of Washington to provide false information to a
14		public servant?
15	A.	That wasn't your question.
16	Q.	That's my new question.
17	A.	Okay. Then yes, I'm aware of that.
18	Q.	Okay. And you would agree that County Council members
19		are public servants?
20	A.	I would agree to that.
21	Q.	So you would agree that it would be a crime to provide
22		them false information during a County Council hearing?
23	A.	Again, that calls for a legal analysis and speculation.
24		I don't have an answer.
25	Q.	There was a County Council meeting on January 24th,

1		2017, that you testified at with prosecutor Gaylord. Is
2		that true?
3	A.	Correct. We spoke in front of them.
4	Q.	What was the purpose of that council meeting?
5	A.	It was just an update.
6	Q.	So when the County Council has a meeting, do they put it
7		on the record with a recorder?
8	A.	I believe so. It's an open, public meeting.
9	Q.	And at that open, public meeting was it recorded?
10	A.	I would assume so.
11	Q.	How did you get on the schedule to be heard by the
12		council for that meeting or that hearing?
13	A.	I don't know. Don't recall.
14	Q.	Did somebody request you to come provide a statement?
15	A.	I don't recall.
16	Q.	Did you notify the council that you wanted to come
17		provide a statement?
18	A.	I don't recall.
19	Q.	How many times have you provided statements to the
20		council in open, public meetings?
21	A.	A number of times.
22	Q.	How do you normally go about getting in front of the
23		council to provide public testimony?
24	Α.	Well, there's two ways. We could ask to come before
25		them, or they could ask us to come before them. Or

1		there's an open public access that you can go before the
2		council.
3	Q.	Did you and prosecutor Gaylord go during open, public
4	2.	access?
5	Α.	No.
6	Q.	So it was either they asked you to come speak to them or
7	Q.	
	_	you asked them to let you come speak to them.
8	A.	Correct.
9	Q.	You don't remember which one it was?
10	Α.	I don't know which one it was.
11	Q.	Did you and prosecutor Gaylord speak with each other
12		prior to that council meeting?
13	Α.	Yes. We speak all the time.
14	Q.	Did you speak about the council meeting prior to
15		attending the council meeting?
16	Α.	I don't recall.
17	Q.	Did you talk to Randy Gaylord about what the two of you
18		would say at the council meeting?
19	Α.	I don't recall.
20	Q.	Did you talk to prosecutor Gaylord about why the two of
21		you were going to speak in front of the council?
22	A.	I've already answered this question. I stand by my
23		answer.
24	Q.	Does the County Council have oversight responsibility
25		over the Sheriff's Office?

1	A.	No.
2	Q.	Do they control your budget?
3	A.	Yes.
4	Q.	And so they can determine how many sheriff's deputies
5		you get to hire. Correct?
6	A.	I don't know. I don't know the answer to that.
7	Q.	Have you expanded the number of sheriff's deputies in
8		your office in the time that you've been Sheriff?
9	A.	I have.
10	Q.	When you expanded the number of sheriff's deputies, did
11		you go to the County Council and request permission to
12		increase the number of deputies you had under your
13		employ?
14	A.	Yes.
15	Q.	Why would you ask them for permission if they don't have
16		oversight authority over the Sheriff's Office?
17	A.	The County Council has budgetary authority. They don't
18		have oversight authority. County Council can can
19		approve a budget increase, but they don't have oversight
20		over the Sheriff's Office.
21	Q.	Well, if they don't think you're using your funds well,
22		they can cut your funds. Correct?
23	A.	I don't know. There's statutory requirements for
24		counties to fund the Sheriff's Office, and that's all a
25		legal area that I am not familiar with, not intimately
		148
		140

1 familiar with.

2	Q.	If the sheriff if the County Council tells you
3		they're not going to allow you to increase the number of
4		sheriff's deputies in your office, that's the end of the
5		story, isn't it?
6	A.	Yes.
7	Q.	And if they say they're not going to increase your
8		budget because they don't think you're using resources
9		well, that's the end of the story, isn't it?
10	A.	Yes.
11	Q.	And if one of your deputies is misusing his debit card,
12		for example, they might want to know what you're doing
13		to make sure the funds they're allotting to you are
14		appropriately spent. Correct?
15	Α.	Correct.
16	Q.	So they at least have oversight over your budget.
17		Correct?
18	Α.	Correct.
19	Q.	And Stephen Parker misused county funds and resources,
20		according to the investigation against him in this
21		matter. Correct?
22	Α.	Correct.
23	Q.	And they wanted to know how somebody like Stephen Parker
24		who could do such a thing was hired by the San Juan
25		County Sheriff's Office. Correct?

1	Α.	I don't believe that was exactly what the question was.
2	Q.	What was the question?
3	Α.	I believe the question that Councilmember Hughes asked
4		was: Is there anything we could have done to or
5		anything we could do in the future to prevent this from
6		happening again?
7		If I recall. As my memory serves.
8	Q.	Did you prepare your remarks at that hearing in advance?
9	Α.	I I believe so, but I don't recall.
10	Q.	Did you allow anyone to review your prepared remarks in
11		advance of that hearing?
12	Α.	I don't recall.
13	Q.	Did you talk to prosecutor Gaylord about your prepared
14		remarks in advance of that hearing?
15	A.	I don't recall.
16	Q.	Prior to the January 24, 2017, council meeting, did you
17		and prosecutor Gaylord have any discussions about the
18		warnings you had received from Jeff Asher in relation to
19		Stephen Parker's hiring?
20	Α.	I believe we did.
21	Q.	When?
22	Α.	I I don't recall. I don't recall the dates or times.
23	Q.	Approximately how long before the County Council meeting
24		on January 24th, 2017, did you and prosecutor Gaylord
25		discuss Jeff Asher's warnings about the hiring of

1		Stephen Parker?
2	Α.	I sent prosecutor Gaylord an email on December 20th.
3		Would have been the only time right now that I
4		recall talking about it. I'm sure we talked about it
5		other times throughout the course of the investigation,
6		but I don't recall how far prior or dates. I just I
7		don't I don't recall.
8	Q.	Prior to the January 24th, 2017, council meeting, did
9		prosecutor Gaylord communicate to you that he wanted you
10		to look back through Stephen Parker's file, look through
11		his full employment file, and see if there was something
12		that you didn't catch?
13	Α.	I believe so.
14	Q.	And when did prosecutor Gaylord say this to you or
15		communicate this to you?
16	Α.	I don't know.
17	Q.	How did he communicate this to you?
18	Α.	I don't know.
19	Q.	Was it in writing?
20	Α.	I don't know. I've answered this question
21	Q.	Was there anyone with you when he communicated that to
22		you?
23	Α.	I don't know.
24	Q.	And did you comply with his request to go back and look
25		at the full employment file and see if there was

1		something in there that you didn't catch?
2	Α.	Yes.
3	Q.	Did you tell prosecutor Gaylord prior to the
4		January 24th, 2017, council meeting, quote, no, there's
5		nothing in there, end quote?
6	Α.	I might have. I don't recall.
7	Q.	Did you remind him of the warning that you had received
8		from Jeff Asher that you had emailed him about in
9		December 20th, 2014?
10	Α.	I don't recall.
11	Q.	As it relates to the background investigation on Stephen
12		Parker, is there anything you could have done
13		differently?
14	Α.	Is that a question?
15	Q.	Yes.
16	Α.	Oh.
17		I don't believe so.
18	Q.	Did you tell the County Council that this is, quote, one
19		of those things that is unidentifiable, end quote?
20	Α.	Yes.
21	Q.	Jeff Asher seems to have identified it. Why didn't you
22		tell the council that?
23	Α.	Because I didn't deem Jeff Asher as a credible source.
24	Q.	Even after you had concluded that Stephen Parker did, in
25		fact, intimidate a witness and misuse county funds and

1		have sex with a complaining witness?
2		MR. McMAHON: Object to the form of the
3		question.
4		MR. COOLEY: Join.
5		THE WITNESS: Yes.
6	BY I	MR. LEE:
7	Q.	Do you think the County Council had a right to know
8		about the Asher warning?
9	A.	Yes.
10	Q.	And why didn't you tell them?
11	A.	Because I didn't think it was a credible warning.
12	Q.	You just said you believed they have a right to know
13		about that warning.
14	A.	Uh-huh. It's a judgment call. I didn't tell them.
15	Q.	Did you tell the County Council: Yeah, we followed up
16		his background all the way, all the way to the Pentagon.
17		I mean, we went overboard. And nothing, nobody anywhere
18		had anything bad to say about him, end quote?
19	A.	Yes.
20	Q.	So you told the County Council on January 24th, 2017,
21		quote, nothing, nobody anywhere had anything bad to say
22		about him, end quote, referring to Stephen Parker?
23		MR. COOLEY: Objection. Asked and answered.
24		THE WITNESS: Yes. I've already answered that
25		question.

1 BY MR. LEE: 2 And, in fact, Jeff Asher had some very bad things to say Ο. 3 about Stephen Parker prior to his hire. Correct? 4 Α. Yes. 5 So your statement to the County Council on January 24th, 0. 6 2017, was false. 7 Α. Yes. 8 Ο. Why did you make a false statement to the County Council 9 on January 4th -- 24th, 2017, about whether or not 10 anyone had said any bad things about Stephen Parker 11 prior to his employ? 12 Α. Again, Jeff Asher has very bad things to say about a lot 13 of people, and I did not deem him credible or his 14 statements credible, so I didn't -- didn't mention it. 15 Does that make it appropriate for you to make a false Q. 16 statement to the County Council? 17 I don't believe it was false. Α. 18 Q. Two answers ago you admitted it was false. 19 Well, okay. Again, it was not a credible -- a credible Α. 20 source, so I stand by my answer that we didn't receive 21 any -- any credible information. 22 Did you tell the County Council that nobody credible 0. 23 anywhere had anything to say about Stephen Parker or 24 nobody anywhere had anything bad to say about him? 25 Which was it?

1	A.	The latter. You read from the transcript of the council
2		meeting so
3	Q.	You finished that sentence. You said: So at what
4		point, you know, it's unfortunate. It's tragic.
5		What was unfortunate?
6	A.	That we were sitting there having to talk about this
7		case with Natalia Garcia and Stephen Parker.
8	Q.	Why is go ahead.
9	A.	That it was thrown out of court and just the whole
10		situation itself.
11	Q.	What's unfortunate about that?
12	A.	Well, justice was not done. I believe a guilty man
13		walked free.
14	Q.	By that you mean Stephen Parker?
15	A.	By that I mean Gerald Grellet-Tinner.
16	Q.	And what was tragic about this case?
17	A.	I just answered that.
18	Q.	Okay. Prior to the County Council meeting on
19		January 24th, 2017, did you and prosecutor Gaylord agree
20		that you would not disclose to the council that you had
21		received a warning from Jeff Asher prior to the
22		employment of Stephen Parker?
23	A.	I don't recall that.
24	Q.	Prior to the County Council meeting on 2000
25		January 24th, 2017, did you and I'll say in the month

1		prior to the County Council meeting, did you and Randy
2		Gaylord have any discussions about this email,
3		Exhibit 1?
4	A.	I don't recall.
5	Q.	Are you saying you can't recall if you did or didn't
6		have any discussions with Randy Gaylord, or are you, in
7		fact, denying that you had any discussions?
8	A.	I can't recall discussions that we had four years ago.
9	Q.	So if prosecutor Gaylord testifies that you and him did,
10		in fact, discuss the Asher warning in a time period
11		leading up to the County Council meeting, you don't have
12		a basis to deny that?
13	Α.	I don't have a recollection of any conversations that we
14		had.
15	Q.	So you may have had a conversation with prosecutor
16		Gaylord about the Asher warning prior to the council
17		meeting; you just can't say one way or the other?
18	A.	Correct.
19	Q.	Is San Juan County a small community?
20	A.	Yes.
21	Q.	How many people are in that county?
22	Α.	About 16,000, give or take, depending on the time of
23		year. Balloons up, tourist season comes, it goes up to
24		a couple hundred thousand.
25	Q.	Did Dr. Tinner's criminal case receive extensive local

1 media coverage? 2 MR. COOLEY: Object to the form. It's vague 3 what you mean by "extensive." 4 THE WITNESS: Yeah. I don't know. Received 5 local media coverage. I'm not aware of how extensive it 6 was. 7 BY MR. LEE: 8 Ο. Is there a local newspaper in San Juan County? 9 There is. Α. 10 Ο. Is there one or two? 11 There's a number of them. Α. 12 0. What are they? 13 There's the "San Juan Islander." There's the "Journal." Α. 14 There's the "Island Weekly." There's the "Sounder." 15 There's the "Orcas Issues." 16 Was the case against Dr. Tinner covered in those Ο. 17 publications? 18 Α. I don't know. It was covered in at least one. 19 You stated that you believe that Dr. Tinner is guilty. 0. 20 Have you reviewed the entire investigative file against 21 Dr. Tinner? 22 Α. No. 23 Ο. Did you attend the trial against Dr. Tinner? 24 I did not attend it, no. I showed up to -- a couple Α. 25 times I went into the courtroom, but I didn't attend it,

1		no.
2	Q.	Did you watch witness testimony in the trial against
3		Dr. Tinner?
4	Α.	I've answered this question already. I stand by my
5		answer.
6	Q.	Yeah. So on what do you draw a conclusion one way or
7		the other about the guilt or innocence of Dr. Tinner?
8	Α.	It's my belief.
9	Q.	Based on what?
10	A.	I don't have to answer that.
11	Q.	Please answer the question.
12	A.	It's my belief.
13	Q.	What do you base your belief on? Because it doesn't
14		sound like you read the file or attended the trial.
15	A.	I've answered the question.
16	Q.	No, you haven't. What do you base that belief on?
17	A.	I've answered the question.
18	Q.	After the just for the record, we're going to note
19		that the answer is non-responsive and we're reserving
20		the right to move for a order from the Court to compel
21		you to answer the question.
22		After the case against Dr. Tinner was dismissed,
23		prosecutor Randy Gaylord was quoted in the media saying
24		that the ruling does not exonerate Dr. Tinner. Were you
25		aware of that?

1	A.	No.
2	Q.	Did you ever hear prosecutor Gaylord say that Dr. Tinner
3		was not exonerated by the dismissal?
4	A.	Not that I recall. I might have. I don't recall.
5	Q.	Do you believe in this country we have a presumption of
б		innocence?
7	A.	I do.
8	Q.	Does that mean that we recognize people as innocent
9		until a final adjudication of guilt after a criminal
10		trial?
11	Α.	I do.
12	Q.	Dr. Tinner's final adjudication is a dismissal of his
13		case. Correct?
14		MR. COOLEY: Object to the form. Calls for a
15		legal conclusion.
16		THE WITNESS: I'm not sure how it was dismissed.
17	BY N	AR. LEE:
18	Q.	Have you ever had any private discussions with Natalia
19		Garcia?
20	Α.	No.
21	Q.	Have you ever met Natalia Garcia?
22	Α.	Once in the office.
23	Q.	In what office?
24	Α.	My office.
25	Q.	When was that?

1	A.	I don't recall.
2	Q.	When you say your office, do you mean the Sheriff's
3		Office collectively or your personal office?
4	Α.	Sheriff's Office collectively.
5	Q.	Where inside the Sheriff's Office?
6	A.	I don't recall.
7	Q.	What was the purpose of the meeting with Natalia Garcia?
8	Α.	I don't recall.
9	Q.	What did you and Natalia Garcia discuss?
10	A.	I didn't discuss anything with her.
11	Q.	What was the purpose of the meeting with Natalia Garcia?
12	A.	I don't know.
13	Q.	Was it before or after you were aware that she had
14		accused Stephen Parker of an affair with her?
15	Α.	It would have been before.
16	Q.	Did you discuss with her the case against Dr. Tinner?
17	Α.	No.
18	Q.	How long did the meeting with Natalia Garcia last?
19	A.	I don't recall. I met her briefly in the office. I
20		believe as I was walking through. And that was it
21		wasn't a meeting between me and her. I believe she was
22		in the office for something else but
23	Q.	Was she with Stephen Parker at the time?
24	A.	I don't recall who she was with.
25	Q.	Do you recall what she was doing in your Sheriff's

1		Office?
2	Α.	I don't.
3	Q.	Was it before or after the jury trial in State of
4		Washington versus Dr. Tinner?
5	Α.	Would have been before.
6	Q.	Was it after the criminal charges had been brought
7		against Dr. Tinner?
8	A.	I don't recall.
9	Q.	Was she with a man or a woman when she was in your
10		office?
11	Α.	I don't recall.
12	Q.	Have you ever apologized to Natalia Garcia for the
13		conduct of Stephen Parker?
14	Α.	No.
15	Q.	Why not?
16	A.	I have not spoken with Natalia Garcia.
17	Q.	Do you believe that Natalia Garcia deserves an apology
18		from the San Juan County Sheriff's Office for the
19		conduct of your deputy, Stephen Parker?
20		MR. COOLEY: Object to form.
21		MR. McMAHON: Join in the objection.
22		THE WITNESS: I believe it would be nice.
23	BY N	MR. LEE:
24	Q.	Have you seen Natalia Garcia in the community at any
25		point since the separation of Stephen Parker from
		161

1 employment with the county? 2 Α. I have not. 3 Do you believe that Stephen Parker failed to disclose Ο. 4 necessary information to Dr. Gerald Tinner? 5 MR. McMAHON: Object to the form of the 6 question. Asked and answered. 7 THE WITNESS: I answered that a long time ago. 8 BY MR. LEE: 9 Do you believe that the San Juan County Sheriff's Office Q. 10 owes an apology to Dr. Gerald Tinner for failure of 11 Stephen Parker to disclose exculpatory evidence? 12 MR. COOLEY: Object to the form. 13 THE WITNESS: Again, I believe it would be nice. 14 BY MR. LEE: 15 Ο. Well, if you'd like to extend that apology now, we can 16 let him know so --17 Α. Okay. 18 MR. Foundation. 9 THE WITNESS: Right now, yes. 10 BY MR. LEE: 11 And are -- how is it you're aware of the reputation of Ο. 12 Stephen Parker for dishonesty in the San Juan County 13 community? 14 It was in the papers. Α. 15 Have you spoken to members of the community about the Q. 16 reputation of Stephen Parker? 17 Α. Yes. 18 Q. And the general reputation of Stephen Parker in the San 19 Juan County community is one of dishonesty. 20 Α. Yes. 21 Was Stephen Parker's work phone seized as part of the Q. 22 investigation into the allegations he was having an 23 affair with Natalia Garcia? 24 Yes. I believe so. Α. 25 Were his phone records searched? Q.

2	Q.	Was his phone itself downloaded and searched?
3	Α.	I don't know for sure. I believe so, but I don't know.
4	Q.	Does anyone at the Sheriff's San Juan County
5		Sheriff's Office utilize Cellebrite technology?
6	Α.	No.
7	Q.	What technology do you utilize to do cell phone data
8		downloads?
9	Α.	We send it out.
10	Q.	Who do you send it out to?
11	Α.	Either the crime lab or Anacortes has done it for us in
12		the past. And I don't know what technology they use,
13		either of them.
14	Q.	Did you send out Stephen Parker's phone or did you or
15		anyone else, to your knowledge, send out Stephen
16		Parker's phone for an analysis as part of the
17		investigation into the allegations stemming from Natalia
18		Garcia?
19	Α.	I believe it was all turned over to the SMART team, and
20		they handled all of that.
21	Q.	So you don't know?
22	Α.	I don't know.
23	Q.	Have you ever had any contact with Natalia Garcia on
24		Facebook?
25	Α.	No.

1	Q.	Has she ever contacted you on Facebook?
2	Α.	No.
3	Q.	How many people can the San Juan County jail hold?
4	Α.	We have two beds in each cell, and then we have a safety
5		cell which holds one person, so technically five, but we
6		have housed people on the floors in there before, so
7		we've had up to four people in each cell.
8	Q.	So what's the total?
9	Α.	Eight or nine.
10	Q.	What are the conditions like in the San Juan County
11		jail?
12	Α.	It's a clean cell. They have mattress pads. They have
13		a toilet. They have a sink and two bunks.
14	Q.	Are there any private rooms, or are they all
15		cohabitation rooms?
16	Α.	They're cohabitation rooms.
17	Q.	What kind of people get housed in the San Juan County
18		jail?
19	Α.	People who are arrested.
20	Q.	Is the San Juan County jail a dangerous place at times?
21	Α.	I don't believe so, no.
22	Q.	Have there ever been any fights inside the San Juan
23		County jail amongst inmates?
24	Α.	I believe there have been one or two altercations over
25		the years.

1	Q.	Has there ever been illegal drugs found in the San Juan
2		County jail?
3	Α.	Not to my knowledge that I'm that I can recall.
4	Q.	When was the last time you ate a meal in the San Juan
5		County jail?
6	Α.	I have never eaten a meal in the San Juan County jail.
7	Q.	You have never sampled the food that is served in the
8		San Juan County jail?
9	Α.	I've had the meals that we serve in the San Juan County
10		jail, but I've never eaten them in the San Juan County
11		jail.
12	Q.	When was the last time you ate one of the meals in
13		the served in the San Juan County jail?
14	A.	It's been years ago.
15		We serve them TV dinners.
16	Q.	Where does the TV dinners come from?
17	Α.	King's market. They're, I believe, Banquet TV dinners.
18	Q.	Do you know why Dr. Tinner's phone was taken to Stephen
19		Parker's home and held there?
20	Α.	No.
21	Q.	Is it appropriate for a detective to take a suspect's
22		phone to their personal residence and retain it?
23	A.	No.
24	Q.	When a suspect's personal phone is taken, should it be
25		locked into an evidence locker?

¹ A. Should be.

2	Q.	Does the San Juan County Sheriff's Office have a policy
3		about deputies at the Sheriff's Office disparaging or
4		making disparaging statements about other deputies?
5	Α.	Yes.
6	Q.	What is that policy?
7	Α.	It's our code of conduct.
8	Q.	What does it say about disparaging other deputies?
9	Α.	It says you will not make disparaging comments or talk
10		poorly about your coworkers.
11	Q.	What if what they have to say about their coworker is
12		disparaging but true?
13	Α.	Doesn't matter.
14	Q.	So if a sheriff's deputy has truthful disparaging
15		information about another sheriff's deputy, the policy
16		is they're just supposed to keep that to themself?
17	Α.	They can bring it to either myself, the undersheriff, or
18		their direct supervisor, not go behind the employee's
19		back and spread it throughout the rank and file, no.
20		MR. LEE: Can I have that marked.
21		(Exhibit 2 was marked for
22		identification.)
23	BY M	R. LEE:
24	Q.	Sheriff, please review Exhibit 2.
25	Α.	Okay.

1	Q.	Have you seen this exhibit before?
2	Α.	I have.
3	Q.	And what is it?
4	A.	It is a letter from prosecutor Gaylord to Deputy Jeff
5		Asher.
6	Q.	And when did you first see it?
7	A.	I believe he cc'ed me on it, so it would have been
8		around February 9th of 2017.
9	Q.	Can you go to paragraph 2 and read the first sentence.
10	A.	"I have met with you, Sheriff Krebs, and Undersheriff
11		Johnson and the County Council."
12	Q.	Do you know what meeting between you and Sheriff Krebs
13		prosecutor Gaylord is referencing?
14	A.	I do not.
15	Q.	Is it true that, prior to this letter being sent on
16		February 9, 2017, you and prosecutor Gaylord had a
17		meeting?
18	A.	Yes.
19	Q.	And it was regarding what's referenced in this letter
20		with the hiring of Stephen Parker?
21	A.	I don't know what it was regarding, but I can assume it
22		was in regards to Deputy Asher's complaints and
23		allegations.
24	Q.	Do you remember prosecutor Gaylord coming to you and
25		saying something to the effect of Deputy Asher was
		168

1		making an allegation against you regarding your
2		statements at the County Council relating to the hiring
3		of Stephen Parker?
4	Α.	I believe so, yes.
5		When did you meet with Randy Gaylord to discuss Jeff
6	Q.	
	-	Asher's allegations against you?
7	Α.	I don't recall.
8	Q.	Who was in the meeting, aside from you and prosecutor
9		Gaylord, where the two of you discussed Jeff Asher's
10		allegations against you related to your comments at the
11		County Council meeting?
12	A.	I don't recall.
13	Q.	Do you not recall the meeting at all?
14	A.	I don't I vaguely recall a meeting. I don't recall
15		who was there, and I don't recall what was discussed.
16	Q.	Is there a reason you can't recall what was discussed in
17		a meeting where you were told by the elected county
18		sheriff that a 30-year veteran of your police agency was
19		accusing you of making a false statement to a county
20		council?
21	A.	I'm sorry. Reword repeat the first part of that.
22	Q.	Is there a reason why you can't remember a meeting where
23		you were told by the elected county prosecutor that a
24		30-year veteran of your police agency was accusing you
25		of making a false statement to a county council?
		169

1	Α.	Like I said, I remember, vaguely remember a meeting. I
2		don't remember who was there, and I don't remember
3		exactly what was said during the meeting. I'm not
4		denying there was a meeting. I just don't recall who
5		was there and what was said.
6	Q.	What was said generally?
7	Α.	I don't recall. I would that would I would have
8		to guess, and I'm not going to guess. I don't recall.
9	Q.	Have you ever had the elected prosecutor come to you and
10		put you on notice that a member of your own police
11		agency was accusing you of making a false statement to a
12		county council?
13	Α.	No.
14	Q.	Have you ever had the elected prosecutor of your county
15		come to you and tell you that a member of your own
16		agency was accusing you of anything?
17	Α.	No.
18	Q.	So this is a pretty unique meeting. Right?
19	Α.	Potentially.
20	Q.	But you don't remember what was discussed at all?
21	Α.	I'm sure what was discussed was the allegations that
22		Jeff had made about Parker, but, again, I don't recall
23		exactly what was discussed.
24	Q.	Did you take any notes?
25	Α.	No.

1	Q.	Did prosecutor Gaylord take any notes?
2	Α.	I don't know. He might have.
3	Q.	In paragraph 2 I'll just read it to you. It says:
4		There is no writing in the file regarding your contact
5		with the undersheriff, former sheriff, or Sheriff-Elect
6		Krebs regarding your concerns about the hiring of
7		Stephen Parker.
8		Do you see that?
9	A.	Uh-huh.
10	Q.	Would Exhibit 1 constitute a writing about Jeff Asher's
11		concerns about the hiring of Stephen Parker?
12	A.	Okay. Yeah.
13	Q.	So this statement in this letter by prosecutor Gaylord
14		is not, in fact, correct, is it?
15	Α.	You would have to ask him.
16	Q.	Well, I'm asking
17	A.	I can tell looking at this, that is correct.
18	Q.	All right. And when you say that is correct, what you
19		mean is that the statement by prosecutor Gaylord in this
20		February 9th, 2017, letter asserting that there was
21		nothing in writing about a warning to you to
22		regarding the hiring of Stephen Parker is not correct.
23	A.	Correct.
24	Q.	It also says in the letter, quote: Without a writing,
25		the date the information was provided cannot be

1 determined with specificity, end quote. 2 Would you agree that it's easy to determine that 3 you were warned by Jeff Asher about Stephen Parker's hiring at some point prior to sending this email on 4 5 December 20th, 2014? б Α. Yes. 7 So what prosecutor Gaylord wrote in that section of the 0. letter that is Exhibit 2 is also not correct? 8 9 MR. COOLEY: Object to the form. It's 10 argumentative. 11 THE WITNESS: Correct. (Exhibit 3 was marked for 12 13 identification.) 14 BY MR. LEE: 15 Sheriff, go ahead and take a moment to look at Ο. 16 Exhibit 3. Let me know when you're done. 17 Α. Okay. 18 Q. I only have brief questions on that one, so you don't 19 need to read it in entirety if you --20 Read the whole thing or --Α. 21 Q. No. Have you seen -- have you seen this letter, 22 Exhibit 3, before? 23 Α. I believe so, yes. 24 When did you first see it? Q. 25 I do not recall it. I don't believe I was cc'ed on Α.

1		this, so I think I probably would have gotten a copy of
2		it from maybe the prosecutor.
3	Q.	Who showed it to you? The prosecutor?
4	A.	I believe so. I know I've seen it. I don't recall who
5		brought it over, whether it was the prosecutor or one of
6		his attorneys. I don't
7	Q.	So going back to Exhibit 2, Exhibit 2 was sent to you
8		February 9th, 2017.
9	A.	Correct.
10	Q.	And Exhibit 3 was sent by Jeff Asher a couple of weeks
11		before that roughly on January 27, 2017. Right?
12	A.	Correct.
13	Q.	Now, you had a meeting with prosecutor Gaylord prior to
14		the sending of this Exhibit 2 letter. Was it after you
15		had received Jeff Asher's letter that is Exhibit 3?
16	A.	I don't I don't know. I don't know. I don't know
17		when that meeting was. Nor do I know which meeting
18		prosecutor Gaylord was even referring to.
19	Q.	If you go back to Exhibit 2, it says, quote: The name
20		of the, quote, source, end quote, or the contact
21		information for that person was not provided, end quote.
22		Do you see that in paragraph 2?
23	A.	Correct.
24	Q.	Did prosecutor Gaylord obtain that information from you?
25	Α.	Correct. Yes, he did.

1	Q.	So you told prosecutor Gaylord prior to him writing
2		Exhibit 2, the letter, on February 9, 2017, that the
3		name of the source or the contact information for the
4		person was not provided.
5	A.	Yes.
6	Q.	Why did you tell prosecutor Gaylord that?
7	A.	I'm sorry. Maybe I misunderstood the question you just
8		asked.
9	Q.	Okay.
10	A.	Can you repeat that question.
11	Q.	I can.
12		I'll back up just a little bit to make sure
13		we're on the same page.
14	A.	Okay.
15	Q.	And I may have to ask the same question but I'll
16	A.	That's fine.
17	Q.	Okay. So there's a sentence in here that says: The
18		name of the source or the contact information for the
19		person was not provided.
20		Do you see that sentence?
21	A.	I do.
22	Q.	And that is information that prosecutor Gaylord obtained
23		from you prior to writing this letter, Exhibit 2.
24		Right?
25	A.	Yes.

1	Q.	My question is: Why did you tell prosecutor Gaylord
2		that the name of the source or the contact information
3		for that person was not provided?
4	A.	I didn't tell I didn't tell the prosecutor that. I
5		don't I don't believe I told the prosecutor that the
6		name was not provided. I provided the prosecutor with a
7		name that I was able to track down, but I didn't tell
8		the prosecutor that I didn't provide him with a name, if
9		I'm understanding your question correctly.
10	Q.	I'm not sure you are, and that could be any number of
11		reasons. It could be the question is just difficult.
12		Did you tell prosecutor Gaylord that Jeff Asher
13		did not give you a source or contact information, a
14		source or the contact information for the person that
15		was his source in Montana that was giving him this
16		information about Stephen Parker prior to Stephen
17		Parker's being hired?
18	A.	I did.
19	Q.	Okay. So why did you tell prosecutor Gaylord that Jeff
20		Asher didn't give you the name of the person in Montana
21		who was giving him this information about Stephen
22		Parker?
23	A.	Because Jeff Asher did not give me the name of the
24		person in Montana.
25	Q.	So go to Exhibit 1 and look at the third paragraph of

1 your email, and please read it out loud. 2 "Jeff claims he was contacted by an attorney friend of Α. 3 his from Montana. The attorney's name is Martin 4 Sinclair. Maybe he has an axe to grind with Parker." 5 Who is Martin St. Claire? 0. 6 Α. I believe it's his contact in Montana. 7 And he gave you that name prior to you writing it in Ο. 8 this email on December 20th, 2014, didn't he? He did not. 9 Α. 10 Ο. "Jeff claims he contacted" -- "was contacted by an 11 attorney friend of his in Montana." 12 Α. Yes. 13 Did he tell you that? Ο. 14 Α. No. 15 Then how do you know Jeff claimed that he was contacted Ο. 16 by an attorney friend of his in Montana? 17 The night Jeff contacted me and gave me this story about Α. 18 the substance that I emailed prosecutor Gaylord about, I 19 asked him numerous times who his contact was. Who do I need to talk to? 20 21 He wouldn't tell me any names, kept going around 22 in circles. 23 So I said -- that's when I decided, okay, I will 24 ask the prosecutor to contact their elected prosecutor, 25 and maybe we can get something.

1 The next morning I was coming into the office --2 I believe it was the next morning, maybe the next 3 early -- sometime the next day I was coming into the 4 office. And Deputy Nicki Rogers stopped me and said she 5 just heard about Stephen Parker from Jeff. 6 And I said: Oh, yeah. He called me last night. 7 And he wouldn't give me any information, wouldn't tell 8 me the guy's name. 9 She said: Well, the name he mentioned was a 10 Sinclair. And she said: I think he reached out to him 11 on LinkedIn. So I asked her, I said: Why do you think she 12 13 reached out to him or he reached out to him on LinkedIn? 14 She goes: It's just something he said. That's 15 what I thought. 16 So I said: Okay. 17 So I didn't know anything about LinkedIn. Ι 18 went and signed up for a LinkedIn account, and I logged 19 into LinkedIn, and I went to Jeff's LinkedIn page, and I 20 went through all of Jeff's contacts in LinkedIn, and I 21 found a Sinclair that was not in Montana. I want to say 22 he was in maybe one of the Dakotas or Wisconsin or 23 Minnesota, somewhere up there. And he was an attorney. 2.4 So I thought: Okay. Well, maybe that's who it 25 is.

1 I included that name, given the fact that Nicki 2 gave me the name of Sinclair, and I included that name with the email to Randy, thinking maybe that would jog 3 4 the memory of the prosecutor in Chouteau County. 5 So that's where I got the name Martin Sinclair from. 6 7 Let me make sure I understand the timeline you just Q. 8 presented. 9 Α. Okay. You had a phone call from Jeff Asher when you were at 10 Q. 11 home Sunday night. Correct? 12 Whatever day that is, yes. Α. 13 And the next day, on Monday, you went and you spoke to Q. 14 somebody who worked at the Sheriff's Office, and they 15 gave you information, and based on that you found this 16 name Martin Sinclair. 17 Α. Yes. 18 But how long did it take you to find the name Martin Q. 19 Sinclair after you talked to that woman on Monday? 20 Α. I don't know what the timeline on that was. I don't --21 I don't recall. But it's your position that you didn't know the name of 22 Q. 23 the attorney Martin Sinclair prior to the next day at 24 work when this employee at the office told you to look 25 at LinkedIn.

1 A. Correct.

2	Q.	Then how is it that Martin Sinclair's name is in the
3		email you wrote Sunday Saturday, December 20th, 2014?
4	Α.	Okay. It was I thought you said Sunday was
5		December 14th.
6		I don't know what the days were. The day Jeff
7		called me at home, sometime after that period I
8		believe it was the next day is when I ran into Deputy
9		Rogers. And then that's when I would have written that
10		email to Randy.
11		The email to Randy I don't know if the the
12		email to Randy didn't go out immediately after I got off
13		the phone with Jeff. The email to Randy went out some
14		time later. And it was after I spoke with Deputy
15		Rogers, who then gave me Sinclair, didn't even give me
16		the last name, gave me Sinclair. I went to Jeff's
17		LinkedIn page, because that's where she said she thought
18		he got it from.
19		I went through all of his contacts and found the
20		only Sinclair in his contacts, which also was an
21		attorney. One of the things Jeff told me about
22		Mr. Sinclair was that he was a judge and he was in
23		charge of the ethics committee, and I want to say he
24		mentioned something about San Francisco even at that
25		point.

1 And nothing on Mr. Sinclair's LinkedIn page had 2 anything about that, but Mr. Sinclair was an attorney, not a judge. So I -- I went with that name, thinking, 3 4 well, that must be the same person, I would guess, and 5 emailed that name to Randy. 6 Ο. I could be confused, but I believe what you testified 7 earlier was that, when you received a phone call at home 8 at night from Jeff Asher about Stephen Parker, you sent 9 an email that night to Randy Gaylord. 10 Α. No. You asked me how I sent an email, if I had access 11 from my home computer, and I said: No. I have access 12 from a work computer. 13 I don't believe we talked about when I sent the 14 email, because I did not send the email as soon as I got 15 off the phone with Jeff. I couldn't have sent the 16 email, because I wouldn't have had that name. 17 So you waited a couple of days? Ο. 18 Α. I believe -- it's possible. But I believe it was the 19 next day. 20 So you believed when you sent this email, Exhibit 1, Ο. 21 that Martin Sinclair was Jeff Asher's source? 22 I wasn't sure. It was -- the name was the name that Α. 23 Nicki -- excuse me -- Deputy Rogers gave me, so that's 24 the name I included in the email. 25 He obviously gave her a name, because that's how

1 she was able to relay a name to me. 2 LinkedIn has a message feature where you can send a Ο. 3 message to people that -- whose profiles you can see. 4 Correct? 5 Yes. Α. 6 Ο. So you believed that the source of the information Jeff 7 Asher was providing you about Stephen Parker was Martin 8 Sinclair. Why did you not send him a message to ask him 9 about Stephen Parker? 10 Α. Because I don't know Martin Sinclair. I wanted Randy to 11 follow up first with Chouteau County, and I wasn't even sure if Martin Claire [sic] was the same person. 12 I'm 13 not going to potentially disparage somebody to someone 14 else that we're not even confirmed is the same person. 15 Did you provide Martin Sinclair's name to the Q. 16 undersheriff and ask him to follow up on Jeff Asher's 17 allegation? 18 Α. I don't recall. I know I didn't ask him to follow up on 19 it. I don't recall if I provided him with a name or 20 not. 21 I provided Randy with the name, and Martin 22 Sinclair was in Montana. The prosecutor would have very 23 good knowledge and information on him. So I opted to 24 allow the prosecutor to do follow-up. 25 Q. Were deputies in your office aware that you had been

1		accused in federal court of groping
2		MR. LEE: What was her name?
3		MR. POWER: Teri.
4	BY M	IR. LEE:
5	Q.	Melanie Teri?
6	A.	Yes.
7		There was another deputy that was involved with
8		it as well.
9	Q.	How is it that you know that deputies in your office
10		were aware that you had been accused of groping Melanie
11		Teri?
12	Α.	I don't know how they're aware. The other deputies
13		talked about it. We had a deposition about it. It was
14		not anything that was hidden or uncommon knowledge.
15	Q.	Do you
16	A.	Maybe not every deputy in the office knew, but it was
17		it was knowledge. It was common knowledge.
18	Q.	Do you believe that it is inappropriate for a police
19		officer to misuse their authority to grope female
20		suspects?
21	Α.	I do.
22	Q.	Do you think that that's something that is appropriate
23		to joke about?
24	A.	I don't.
25	Q.	You don't think it's appropriate for members of law

1		enforcement to joke about about using your position
2		as a law enforcement officer to kind of get away with
3		groping females?
4	Α.	I do not agree with that.
5	Q.	Would you agree that, if a sheriff, if an elected
6		sheriff was joking about groping female suspects, that
7		that would send the wrong message to the deputies
8		underneath you?
9	Α.	Yep.
10	Q.	Did you ever make any jokes, public or private, about
11		members of law enforcement groping females?
12	Α.	I don't recall.
13	Q.	Are you denying that you have made jokes about members
14		of law enforcement groping females?
15	Α.	I'm not denying it. I just don't recall.
16	Q.	Have you heard other deputies joke at the San Juan
17		County Sheriff's Office about groping females?
18	Α.	I don't recall.
19	Q.	Have you ever posted anything on any social media that
20		makes light of or jokes about members of law enforcement
21		groping women?
22	Α.	I don't recall.
23	Q.	Do you deny posting on Facebook a video of a uniformed
24		individual groping women at a security checkpoint?
25	Α.	I don't recall.

1	Q.	Do you have a Facebook account?
2	Α.	I do.
3	Q.	How long have you had it?
4	A.	A number of years.
5	Q.	Do you think it's appropriate for security guards to
6		grope women in the course and scope of their employment?
7	Α.	No.
8	Q.	Is your Facebook page profile public?
9	Α.	No.
10	Q.	Who can see okay. Let me back up.
11		When you opened up when did you open up your
12		Facebook social media page?
13	Α.	I don't recall.
14	Q.	Do you recall how long you've had it?
15	Α.	No.
16	Q.	Do you know how many Facebook friends you have?
17	Α.	I do not. I'm rarely on there anymore.
18	Q.	Okay. In the past have you ever been on there quite a
19		bit?
20	Α.	Depends on what quite a bit is, but I've been on there
21		in the past.
22	Q.	Were you criticized in local newspapers or a local
23		newspaper about the amount of time you spent on
24		Facebook?
25	Α.	Yes.

1 Ç	Q.	What media organization or newspaper criticized you for
2		the amount of time you spent on Facebook?
3 <i>I</i>	Α.	That was an opinion piece by a gentleman from Shaw
4		Island. I believe he put it on the "San Juan Islander."
5 Ç	Q.	And what was the general thrust of the opinion piece
6		about your use of social media?
7 J	Α.	The thrust was that I am on there a lot, way more than
8		is humanly physically possible.
9 Ç	Q.	And when did that opinion piece get published?
10 <i>p</i>	Α.	Right around the election time.
11 Ç	Q.	And have you changed your social media habits since that
12		opinion piece came out?
13 J	Α.	No.
14 Ç	Q.	Were you ever a frequent user of Facebook?
15 J	Α.	I wouldn't say I was frequent, no.
16 Ç	Q.	So the characterization in the media about your use of
17		Facebook was totally unfounded. Is that your position?
18 J	Α.	Yes.
19		MR. LEE: Can we mark that.
20		(Exhibit 4 was marked for
21		identification.)
22 E	BY M	R. LEE:
23 Ç	Q.	Sheriff, please go ahead and look at Exhibit Number 4.
24 <i>J</i>	Α.	Okay.
25 Ç	Q.	This is a post that you made on Facebook. Correct?
		105

1 MR. COOLEY: Object to the form. It's vague 2 what you mean by "made." MR. LEE: Okay. I'll rephrase. 3 4 BY MR. LEE: 5 Ο. You posted -- you put this post on Facebook. б Α. Okay. 7 Ο. Yes? 8 Α. Yes. 9 And we're looking at a piece of paper, but you actually Q. 10 recall this was a video that you posted on your Facebook 11 page. Correct? 12 MR. COOLEY: Object to the form. It's vague 13 what you mean by "posted." 14 THE WITNESS: Yes. 15 BY MR. LEE: 16 And the video that is displayed in this exhibit is one Ο. 17 where that security guard, who's seen in the exhibit, 18 repeatedly groped women who were going through his 19 checkpoint. Is that correct? 20 I don't recall exactly what was in the video. I don't Α. 21 recall -- how long ago was this? Do you know? 22 Yeah. I don't recall. 23 Ο. 1	Q.	Is it your experience on social media that people post
2		emojis such as the laughing, crying, smiling face, when
3		something is funny?
4	Α.	Yes.
5	Q.	And so what was your intent when you posted a video on
б		Facebook of a security officer groping women at a
7		checkpoint?
8	Α.	I don't know.
9	Q.	Did you think it was a funny video of this individual
10		officer groping women at a security checkpoint?
11	A.	Well, without knowing exactly what the video was, I

I don't recall. 20 Α. 21 Would you agree that, if an elected county sheriff posts Ο. 22 a video saying it's funny, where in a video a security 23 officer is groping women, that might send the wrong 24 message to sheriff's deputies? 25 MR. COOLEY: Object to the form. It's vague 188

1 what you mean by "security officer." 2 THE WITNESS: And yes, I would agree with that. 3 Can I have that one marked. MR. LEE: 4 (Exhibit 5 was marked for 5 identification.) 6 BY MR. LEE: 7 Ο. Sheriff, have you seen the letter that's marked as Exhibit 5? 8 9 I believe so, yes. Α. 10 Ο. And what is Exhibit 5? 11 It's a letter from Jeff Asher to prosecutor Gaylord. Α. 12		case to an outside agency for criminal investigation?
13	Α.	He did not.
14	Q.	What did prosecutor Gaylord tell you about whether or
15		not he was going to send the case to an outside agency
16		for a criminal investigation?
17	A.	I'm not sure it even came up. That would be his
18		prerogative, and if he was considering it he did not
19		consult me.
20	Q.	Why was the case against Stephen Parker sent to an
21		outside agency for an investigation?
22	A.	The are you talking about the Parker-Natalia case?
23	Q.	Yep.
24	A.	Because Stephen Parker was a detective.
25		I have two detectives. The other detective is
		100

1 the detective that sits right next to him in the office. 2 For, one, caseload and, two, transparency I didn't want 3 to include the only other detective I have to 4 investigate his partner. It just wouldn't be 5 appropriate, and so I opted to send it to Skagit County. 6 Q. So would you agree that, when there has been an 7 allegation against somebody inside your own agency, it 8 should be sent to an outside agency for investigation? 9 Α. No. 10 MR. 22	A.	I believe so.
23	Q.	And what is Exhibit 7?
24	Α.	It's a step-by-step kind of a synopsis of the misconduct
25		of Detective Parker.

And why did you produce this? 2 I don't recall why I produced it, other than maybe for Α. 3 his file, or it's possible I produced it for the 4 Criminal Justice Training Commission as we were sending him in to have his certification revoked. 5 6 Q. Is there anything that you believe needs to be changed, 7 modified, corrected in the report you produced Exhibit 7? 8 9 I don't know. Α. 10 0. Go ahead and take an opportunity to look at it and let 11 me know. 12 MR. COOLEY: It's four pages single-spaced --13 THE WITNESS: I'm not going to have time to --BY MR. LEE: 14 15 You don't believe you intentionally wrote anything wrong 0. 16 in there, do you? 17 I don't believe I intentionally wrote anything wrong, Α. 18 no. 19 Did you have anyone review it before you printed it out Ο. 20 and signed it? 21 Α. 16		Do you have any idea why she changed her story

19	Q.	Do you believe it's because he pressured her to change

21		MR. McMAHON: Object to form.
22		THE WITNESS: I don't know. I don't know why
23		she changed her story.
24	BY M	IR. LEE:
25	Q.	Was she told to fix it by Stephen Parker?

2		THE WITNESS: I don't know.
3	BY N	NR. LEE:
4	Q.	Says on September 21st the victim agreed to provide a
5		new statement and an investigation was reopened. Do you
6		see that?

8	Q.	Why did she I'll say this. Who asked her to provide
9		a new statement?
10	Α.	I don't know.
11	Q.	Do you know why she provided a new statement?
12	Α.	I don't.
13	Q.	Was he on administrative leave prior to her providing
14		that new statement, Stephen Parker?
15	Α.	No.
16	Q.	It says: In the interim Mr. Parker was placed on paid
17		administrative leave.
18		Do you know when that began?
19	A.	That would have been as soon as we received the
20		statement from Miss Garcia.
21	Q.	The third statement about Stephen Parker from her?
22	A.	The one after she recanted her story. She gave another
23		one on or about September 21st, so it was that statement

25	Q.	So statement number one from Natalie Garcia is that she

1 had a sexual relationship with Stephen Parker. 2 Statement number two is that she said she didn't have a 3 sexual relationship with Stephen Parker. And statement 4 number three is the same as statement number one, being 5 that she had a sexual relationship with Stephen Parker. 6 Correct? 7 Correct. Α. 8 Ο. When she made statement number one, you did not put him 9 on administrative leave? 10 Α. Statement number one was just a verbal admission, which 11 then came to our office. 2	Q.	What do you mean when you say a substation?
3	A.	I have a station where the deputies, the resident
4		deputies on Orcas Island go to, to do their reports.
5		There's a temporary holding facility in there. There
6		are computers, desk. It's the office space on Orcas.
7	Q.	If you go down to section 2, disrespectful conduct
8		towards victim.
9	A.	Yes.
10	Q.	Go ahead and read that section to yourself. Let me know
11		when you're finished.
12	Α.	Okay.
13	Q.	You concluded, based on your review of the SMART report,
14		that at times quote, at times the sex is described by
15		the victims in ways that shows disrespect and conduct
16		that is uniquely unbecoming of an officer, sometimes
17		unexpected, demeaning, and embarrassing, end quote.
18	A.	Yes.
19	Q.	What was disrespectful of Miss Garcia on the part of
20		your deputy, Stephen Parker?
21	A.	I would have to go back and look at the Skagit report.
22		I believe it was just the different acts, sexual
23		acts, is my recollection. I don't recall the specific
24		acts that were committed.
25	Q.	Well, just generally. I mean, sex is not inherently a

1 disrespectful act.

2	Α.	No. I believe there was some I don't recall. It
3		was it was maybe they had anal sex and she didn't
4		like it and he wanted to do it but she allowed him.
5		I believe there was maybe oral sex in there that
6		was involved that was disrespectful, if I recall
7		correctly.
8		Like I said, I have to go back and read the
9		report, but what I read led me to believe it was
10		disrespectful and not something normal or respectful.
11	Q.	In section 4 you call out the fact that Stephen Parker
12		used aliases to hide his communications with

15	Q.	Was it your opinion that the use of an alias indicated
16		that Mister Deputy Parker knew his actions as it
17		relates to Miss Garcia were improper?
18		MR. McMAHON: Object to the form of the
19		question.
20		THE WITNESS: I believe he was doing everything
21		he could to hide it from his wife, so
22		MR. LEE: What's the setup language? Which one
23		is that?
24	BY N	IR. LEE:
25	Q.	Sheriff, in section 7

1 MR. LEE: Thank you. 2 BY MR. LEE: 3 -- about halfway down, you wrote that of particular 0. 4 concern are the statements by Mr. Parker to the victims' 5 advocate that the victim set up the teacher and that she 6 was reluctant to testify, end quote. 7 Did I read that correctly? 8 Α. Yes. 9 When you say that Stephen Parker said that the victim Q. 10 set up the teacher, the person you're referring to as 11 the victim is Natalia Garcia. Correct? 12 Α. I agree, 22 yes, that Detective Parker said that. 23 Ο. Said that Natalie Garcia set up Dr. Tinner? 24 I believe he said she sets people up, is what he said. Α. 25 Q. And here in your conclusions it's specifically that

1 Natalie Garcia set up Dr. Gerald Tinner. 2 Α. Okay. 3 Is that correct? Yes or no? Q. 4 Α. Yeah. That's what's in here, yes. 5 0. Thank you. 6 Would you agree that, if Stephen Parker, one of 7 your deputies, had reason to believe that complaining 8 witness Natalie Garcia set up Dr. Tinner, Stephen Parker 9 had an obligation to disclose that information 10 immediately to Dr. Tinner's defense team? 11 Yes. Α. 12 Ο. Is Stephen Parker a liar? 13 Α. Yes. 14 MR. McMAHON: Object to the form of the 15 question. 16 THE WITNESS: I believe so. 17 BY MR. LEE: Q. 18 Would you describe Stephen Parker's misconduct as 19 shocking to the conscience? 20 Α. Yes. 21 MR. 8	A.	Undersheriff Zac Reimer.
9	Q.	Is he currently an undersheriff?
10	A.	Yes.
11	Q.	And how does an officer get on your Brady list?
12	A.	It is generally something that either the prosecutor or
13		the sheriff places the officer on.
14		This came from a Skagit County excuse me a
15		Whatcom County prosecutor that put him on a Brady list.
16	Q.	And when did the are there any other officers on the
17		Brady list?
18	A.	Not that I'm aware of.
19	Q.	And what are the criteria for being placed on a Brady
20		list?
21	A.	Well, generally it's dishonesty, or it could be
22		conflicting testimony. There's a number of things that
23		could put you on a Brady list.
24	Q.	And when you're saying that your current undersheriff
25		is on the Brady list because of a letter placing him on
		206

1 the Number Two person in your office. Right? 2 Yes. Α. 3 And prior to making him your current undersheriff you Q. 4 were aware that he had already been placed on the Brady 5 list because of a letter from the San Juan County 6 Prosecuting Attorney's Office -- or excuse me -- Skagit 7 County Prosecuting Attorney's Office? 8 MR. COOLEY: Whatcom. 9 Whatcom County. MR. LEE: Thank you. 10 THE WITNESS: Yes. The Whatcom County attorney, 11 yes. 12 BY MR. LEE: 13 And you were aware that he was placed on that Brady list Ο. 14 for dishonesty? 15 Yes. Α. 16 Yet you made him the Number Two person at the sheriff's Ο. 17 office? 18 Α. 10		well, does that refresh your recollection at all?

17	Q.	So in the video that you posted on Facebook, now that

21	Q.	Do you think that that is something to laugh about?

23	Q.	Did you post it anyhow and say that it was funny?
24	Α.	I possibly did. I posted it, obviously. I don't recall
25		what I was thinking at the time or, like I said, even

how long ago it was.

10	A.	I don't. They live on Orcas Island, and my office and
11		where I spend the vast majority of my time is on San
12		Juan Island, so they're two totally different
13		communities and I don't I don't have any knowledge or
14		anything of her or them.
15	Q.	Do you have any knowledge or information where she
16		currently resides?
17	A.	I don't.
18	Q.	You testified that you on one or two occasions, maybe a
19		few more times, popped your head into the courtroom
20		during the trial of Mr. Tinner. Do you recall that
21		testimony?
22	A.	I do.
23	Q.	And I take it from your answer that you weren't in there
24		for any sustained period of time observing the testimony
25		of the trial proceedings. Is that accurate?

13		prosecuting Mr. Tinner had presented that evidence
14		through a pathologist from the state crime lab?
15	A.	Yeah. I don't know how he presented it. I know that it
16		was presented.
17	Q.	Did you come to learn during the course of the trial
18		that Mr. Tinner's defense attorney presented no refuting
19		evidence or contradictory evidence to that DNA
20		testimony?
21	Α.	Yeah. I don't know.
22	Q.	Have you come to learn since that that never was
23		presented?
24	Α.	I don't recall. I might have heard that, but I don't
25		recall.
		212

1	Q.	Has anyone indicated to you that Mr. Tinner's criminal
2		defense attorney was somehow not competent in his
3		representation of Mr. Tinner during his criminal trial?
4	Α.	No.
5	Q.	A lot of testimony and questions regarding former deputy
6		Asher from your department.
7	Α.	Yes.
8	Q.	And he's no longer with your department. Is that my
9		understanding?
10	Α.	Correct.
11	Q.	When did he leave?
12	Α.	January of this year, 2019.
13	Q.	And how many years did he serve as a deputy sheriff?
14	Α.	Approximately 30.
15	Q.	During that period of time when after Mr. Parker was
16		hired on as a detective with your department or with
17		your Sheriff's Office, it appears that Mister or
18		Deputy Asher took it upon himself to do his own
19		investigation, background investigation, and continuing
20		investigation regarding Deputy Parker.
21		Is that an accurate statement from your
22		perspective as the sheriff of the county?
23	Α.	Yes.
24	Q.	So some of these exhibits that were presented where Jeff
25		Asher, Deputy Sheriff, is presenting emails or letters

1		to either the prosecutor or to yourself regarding his
2		thoughts and his opinions regarding Detective Parker,
3		was that done on county time? Do you know?
4	A.	I I don't know.
5	Q.	Do you know if he used county facilities to do the
6		investigation, computers, typing it out on county
7		property?
8	А.	I don't know.
9	Q.	Would that have been authorized?
10	A.	It depends. It would be a case-by-case basis,
11		potentially. It maybe wouldn't not be authorized.
12		It there's that's there's a lot to it that
13		that I would have to look at, whether or not it would be
14		authorized or unauthorized.
15	Q.	Is that something that you would encourage, that
16		somebody like Deputy Asher, who has somewhat of an axe
17		to grind with Detective Parker, would take it upon
18		himself to do his own internal investigation to
19		discredit someone that came with high credentials to be
20		a deputy sheriff in your department?
21	A.	Are you talking about the original information he
22		received, or are you talking about something that
23		happened beyond that, much later than that?
24	Q.	From the original all the way through until he retired.
25	A.	Then I would say no, that's not something I would

2	Q.	Do you have any information whether Asher ever went to
3		any other law enforcement agency or any other
4		prosecuting authority to do their separate investigation
5		into his allegations regarding Detective Parker?
6	Α.	I'm sorry. Deputy who? Parker?
7	Q.	Yes.
8	Α.	Oh. I don't.
9	Q.	All right. So, to the best of your knowledge, you don't
10		know whether Asher went to another prosecuting attorney
11		in another county and said: Hey, take a look at
12		Detective Parker. He's got some issues I'm concerned
13		with.
14	Α.	No. I don't know that. Don't know if he did.
15	Q.	30-year law enforcement officer. Did he go to any other
16		law enforcement agencies and ask for an assist to do
17		background checks and to verify any of the complaints
18		and allegations he was making about Mr. Parker?
19	Α.	Not that I'm aware of.
20	Q.	I came away with a distinct impression based on the
21		questions you were asked, Sheriff, that you're of the
22		opinion that Deputy former Deputy Asher has an axe to
23		grind or a grudge against Mr. Parker.
24		Is my assessment accurate?
25	Α.	Yes. I would agree with that.

1	Q.	And what was that based on, from your perspective as the
2		sheriff?
3	Α.	I don't know.
4	Q.	You indicated that Asher has a tendency to behave that
5		way with other deputies over his 30-year tenure or for
6		how many years you were associated with him in law
7		enforcement?
8	A.	Yes.
9	Q.	And I think I heard you use the word he has a certain
10		paranoia with other officers.
11	A.	Yes.
12	Q.	Has he been passed over for promotions during his tenure
13		as a deputy sheriff in your office?
14	A.	I don't know. I believe so, but, yeah, I don't know.
15		I'd have to go back and look at his file.
16	Q.	And I understand you don't have his personnel file with
17		you.
18	A.	Yeah.
19	Q.	Do you have an independent recollection whether he ever
20		served as a detective investigating sex crimes?
21	A.	He did serve as a detective years ago, yes.
22	Q.	Did he do so while he was under your command?
23	A.	No.
24	Q.	Did Asher ever come to you, as the sheriff, and lodge
25		any complaints about how Detective Parker was

1		investigating Tinner's sexual activity with Natalie
2		Garcia?
3	A.	I don't believe so, no. No.
4	Q.	Now, he ran against you for the elected position of
5		Sheriff of San Juan County. Is that correct?
6	A.	He did.
7	Q.	And what year was that?
8	A.	Last year, 2018.
9	Q.	So that was after the Tinner trial. Is that correct?
10	A.	Yes.
11	Q.	And he lost, obviously.
12	A.	Yes.
13	Q.	What was the margin of defeat?
14	Α.	It was fairly large. 12, 13 percent. I don't recall.
15	Q.	Had he run for the position of sheriff prior to you
16		becoming the elected sheriff?
17	Α.	Yeah. This was, I believe, his fourth time running.
18	Q.	And has he ever been elected by the citizens of San Juan
19		County to hold the highest law enforcement position in
20		the county?
21	A.	No.
22	Q.	Since he has retired from law enforcement, does he have
23		the ability, if you can educate me, to run for Sheriff
24		when your term expires?
25	A.	Yes.

	1	Q.	All right. So, in other words, he he's still
	2		accredited with the Washington State Criminal Justice
	3		Training Commission?
	4	Α.	Yes.
	5	Q.	And he may not necessarily serve on any department, but
	6		he could conceivably file to run for Sheriff in San Juan
	7		County against you.
	8	Α.	Yes.
	9	Q.	Have you heard any rumblings that he may attempt to
	10		unseat you in your next election?
	11	Α.	No.
	12	Q.	When does your term expire?
	13	Α.	Two this is the first year, so three years from now.
	14		2022.
	15	Q.	And it may be somewhat premature to ask you, but do you
	16		plan on running again?
	17	Α.	Yes.
	18	Q.	How old are you?
	19	Α.	51. 51.
	20	Q.	And I believe you were asked this question, but help me
	21		out. How many years do you have in law enforcement?
	22	Α.	I have about 13 years, roughly.
	23	Q.	When the Skagit County Sheriff's Department, the SMART
	24		team, did their investigation into the allegations
	25		levied against Detective Parker, how was that agency
			218

1 chosen? 2 I chose them. I -- they were the county right next door Α. 3 It was logistically easy for them -- for us -to us. 4 me to go over to meet with them, for them to come over 5 here, should they need to. So I chose Skagit County. 6 Q. Is that within your discretion --7 Α. Yes. 8 Ο. -- as the elected sheriff? 9 Α. Yes. 10 Have you reciprocated? In other words, has San Juan Ο. 11 County done investigation for Skagit County? 12 Α. No. 13 Has your county done investigations for other law Ο. 14 enforcement entities? 15 No. Α. 16 And do you know why? Ο. 17 Α. No. 18 Q. Smaller department or --19 Yeah, it's possible. It's -- we're -- we have two Α. 20 detectives so -- and they all know that. All the 21 counties in our area know that. 22 So for them -- for us to handle an investigation 23 on another agency would take essentially 50 percent of 24 my detective force out to go do it, where you have 25 Anacortes or Skagit or Whatcom that have a very large 219

1 detective cadre that could handle it much easier. 2 And the SMART team is a Skagit multiagency 3 response team -- that's all the counties in Whatcom, 4 Skagit, and I believe Island County now -- that dedicate 5 either a detective or two to this team that then that's 6 what they do. 7 So the team -- the team that did the investigation into Ο. 8 Detective Parker had representatives from other law 9 enforcement agencies other than just Skagit County. 10 Α. I would assume so. I don't recall exactly who was on 11 the team or who was in charge of the investigation into Deputy Parker. We used the SMART team. 12 It could have 13 been just Skagit County detectives. 14 I don't know. I don't remember. 15 Do you have a recollection of how it came about that you Q. 16 were going to turn that investigation over to Skagit 17 County or the SMART team? Did you make the request or 18 did your undersheriff? 19 No. I made the request. Δ 20 And would that be a phone call from sheriff to sheriff? Ο. 21 Α. I believe I called Sheriff Reichert, yes, and he put me 22 in touch with Tom Molitor, who I think at the time --23 M-o-l-l-i-t-o-r [sic]-- who I believe at the time was 24 the -- either the chief or the head of the SMART team. 25 Q. And after that investigation no criminal charges were

1 ever filed against former Detective Parker. Is that 2 correct? 3 Α. That's my understanding. 4 So all of the discussion about whether he may or may not Ο. 5 have committed perjury or he may or may not have 6 committed some sort of crime, no legitimate prosecuting 7 authority from any county has ever filed a criminal 8 charge against former Detective Parker. Is that 9 correct? 10 It's my understanding. Α. 11 Are you aware that Mr. Tinner took it upon himself, as a Ο. 12 non-law enforcement person, to attempt some sort of 13 prosecution or court proceedings against Mr. Parker? 14 Α. I heard something about it. I'm not intimately aware of 15 details into that, but I did -- I heard something about 16 it. 17 You state that you don't have intimate details about it. Ο. 18 Give me your best recollection of what you recall having 19 heard or been educated about. 20 Α. Sorry. 21 I think I just -- I think I heard it either in 22 the community or I read about it in the paper. I heard 23 about it somewhere. 2.4 I don't believe there was any actual 25 conversation between the prosecutor's office and my

1 office or anything. It's entirely possible that I heard 2 about it from one of the prosecutors that's in my office 3 almost daily. It might have been mentioned there. Т 4 don't recall where I heard about it, and I -- I don't know anything else other than that. I didn't look into 5 6 it or investigate it or research it or anything. 7 Do you have any understandings whatever proceedings 0. 8 Mr. Tinner attempted to bring against Mr. Parker were 9 ultimately dismissed or thrown out of court? 10 Α. No. I don't. 11 And, to go back one, I will say that I do 12 remember thinking that it was odd that somebody other 13 than the Prosecuting Attorney can file charges against 14 someone else, and that was -- I thought that, and that 15 was really the end of it. It's where I stopped thinking 16 about it. 17 Other than Tinner engaging in that process, you've had Ο. 18 no experience or haven't learned about that in your law 19 enforcement experience? I'd never heard of that before. 20 Α. 21 How long has prosecutor Gaylord been the elected Q. 22 prosecutor in San Juan County, approximately? 23 Α. 20-plus years. 24 As long as you --Ο. 25 Α. Is my guess.

1	Q.	As long as you've been in law enforcement?
2	Α.	Yes.
3	Q.	And from your exposure to him as a prosecuting
4		authority, do you have respect for his abilities as a
5		prosecutor?
6	Α.	I do.
7	Q.	Do you have respect for his integrity as a prosecuting
8		attorney?
9	Α.	I do.
10	Q.	And did you question at all in the back of your mind, as
11		an experienced law enforcement officer and as the
12		Sheriff of San Juan County, that he was justified in
13		bringing criminal charges against Tinner for the felony
14		crime of having sexual relations with a student?
15		MR. POWER: Calls for legal conclusion.
16		THE WITNESS: Yeah. I would say that I trust
17		his judgment, but I wouldn't be able to answer that
18		question. That's not a decision I would make. Not a
19		decision I can make, so it's out of my authority.
20	BY M	R. McMAHON:
21	Q.	What can you tell me, based on your recollection, again
22		recognizing you haven't reviewed Asher's personnel
23		file were there any disciplinary issues that he's
24		undergone while you've been Sheriff?
25	Α.	Yes. There's yes.

1	Q.	What's your recollection of what those disciplinary
2		issues were?
3	Α.	He's had a number of write-ups for failure to follow
4		procedure, failure to follow the chain of command, for
5		failure to properly complete investigations. Those are
6		some of the ones that come to come to mind.
7	Q.	In your sheriff's office, sheriff's department, you
8		mentioned sergeant somewhere in your earlier testimony.
9		What's the chain of command? You have a deputy sheriff?
10		You have corporals?
11	Α.	So the chain of command is
12		Excuse me just one second. Can we take a break
13		real fast?
14		MR. McMAHON: Sure.
15		THE VIDEOGRAPHER: I'm off the record.
16		(At 3:41 p.m. a recess was taken until
17		3:42 p.m.)
18		THE VIDEOGRAPHER: Back on the record.
19	BY N	IR. MCMAHON:
20	Q.	We took a quick break there so you could answer a phone
21		call, Sheriff. And I was asking you about the chain of
22		command within your sheriff's department.
23	Α.	Yes. So the chain of command is deputy sheriff,
24		sergeant, undersheriff, and sheriff. I have a chief
25		civil deputy that manages the civil side, which would be
		224

1		dispatch, and two in the civil office. I have two
2		detectives that kind of fall under the undersheriff, not
3		the sergeant, and I have two Corrections that also fall
4		under the undersheriff directly.
5	Q.	So a deputy patrol sheriff, his or her stripes would be
6		to the sergeant level?
7	A.	Correct.
8	Q.	Did Asher ever obtain any stripes?
9	A.	Not that I'm aware of, no.
10	Q.	Was he ever demoted that you're aware of?
11	A.	I'm I don't I don't recall the circumstances of
12		him leaving the detectives office. I don't know. That
13		would be the only demotion he would have had, if he had
14		one, and I don't know that he was demoted.
15	Q.	So from your perspective as the elected sheriff for San
16		Juan County, have any of Asher's complaints regarding
17		Stephen Parker been substantiated?
18	A.	No.
19	Q.	And you were asked a question that about the
20		presumption of innocence. We're all presumed innocent,
21		even though we may or may not be charged with a crime.
22		You remember that general line of questioning?
23	A.	I do.
24	Q.	And that certainly would apply to my client Mr. Parker
25		as well, that he's presumed innocent of any thoughts or

1		allegations that somehow he manipulated the evidence
2		involving Natalie. Isn't that correct?
3	Α.	Yes.
4	Q.	You were asked somewhat of an embarrassing question that
5		a complaint was made against you for grabbing a female's
6		breasts. Do you recall that
7	Α.	Yes.
8	Q.	questioning? Okay.
9		And did that that resulted in a lawsuit? Did
10		I understand that correctly?
11	Α.	Yes.
12	Q.	And the person, the female that was the plaintiff in
13		that lawsuit, was she in custody?
14	Α.	She was.
15	Q.	At the time she filed the lawsuit?
16	Α.	Yes.
17	Q.	And are you denying the allegation?
18	A.	I am. Wholeheartedly.
19	Q.	So it was her word against your word.
20	Α.	Yes.
21	Q.	And there wasn't any physical evidence to substantiate
22		whether that happened or didn't happen?
23	Α.	Correct.
24		There was actually another deputy there that was
25		with me also.
		226

1 The evidence of motel receipts and whatnot in the Q. 2 investigation of Detective Parker, that doesn't 3 establish in any way that he actually had sexual 4 intercourse or sexual relations with Natalie Garcia in 5 that particular motel room, does it? 6 Α. The evidence of hotel room receipts -- no, it does not 7 establish that actually sex took place, no. 8 There wasn't any third party that had any independent Ο. 9 knowledge or information that Detective Parker actually engaged in any sort of sexual activity with Natalie 10 11 Garcia. Correct? 12 Correct. Α. 13 When you were asked questions about your understanding Q. 14 of the case Brady versus Maryland and the recent 15 phenomenon we've seen about law enforcement officers 16 being placed on a Brady list, is it your understanding, 17 Sheriff, that if an officer is placed on a particular 18 Brady list, that whatever got that officer on the list, 19 that information is not necessarily admissible in any 20 subsequent criminal trial where that officer may be a 21 witness? 22 That's my understanding, yes. Α. 23 That's discretionary with the Court. Q. Correct? 24 Α. I would assume so. That's -- yeah. 25 Your obligation is whatever you deem to be a Brady Q.

1		violation, whether it be somewhat minor or be somewhat
2		more more serious or egregious, that information is
3		to be provided to the criminal defense attorney and the
4		criminal defendant as potential exculpatory evidence.
5		Is that correct?
6	Α.	That's my understanding, yes.
7	Q.	And I don't know if you were asked the question, but was
8		Detective Parker ever placed on a Brady list before
9		Natalie Garcia disclosed that she had been sexually
10		abused by Tinner?
11 .	Α.	No.
12	Q.	Based on the background check of Detective Parker from
13		the other agencies he served with and being an
14		investigator for the Air Force, criminal investigator
15		for the Air Force, did you have any knowledge that he
16		was placed on any sort of Brady list with those entities
17		before joining your organization?
18	Α.	No.
19	Q.	Your department, your sheriff's office or department
20		runs the jail in San Juan County?
21	Α.	Yes.
22	Q.	It's not run by the commissioners?
23	Α.	No.
24		It's not really a jail. It's more of a holding
25		facility, a temporary holding facility.
		228

1	Q.	So on District Court convictions or sentencing, do they
2		serve their entire time on a misdemeanor, gross
3		misdemeanor in your jail, or do they go somewhere else?
4	A.	No, they go somewhere else.
5	Q.	Where does San Juan contract with?
6	A.	We contract with Yakima.
7	Q.	Okay. The time that Tinner was in custody for sexually
8		assaulting Natalie Garcia, was he incarcerated in the
9		San Juan County jail the entire time?
10	A.	No. I don't believe he was.
11	Q.	Were there any reports that he had been mistreated while
12		he was in your jail, the San Juan County jail?
13	A.	Not that I'm aware of.
14	Q.	Was he ever placed in any sort of segregation?
15	Α.	Not that I'm aware of.
16	Q.	Do you have a segregation for your smaller jail?
17	Α.	We do. We have a safety cell that's rubber-coated
18		walls.
19	Q.	And to place someone in segregation, that particular
20		inmate or guest, if you will, would either be
21		potentially harmed by other inmates correct?
22	Α.	Correct.
23	Q.	or they're placed in segregation as a potential
24		penalty for the way they're acting in jail. Is that
25		correct?
		229

1 Α. Yeah. It's -- our guidelines generally, if you're a 2 safety risk to other officers, to other inmates, or to 3 yourself is when they go into the safety room. Ιf 4 they're acting out, like, you know, trying to flood the 5 cell or do something malicious mischiefwise, then, yeah, 6 they'll go into the safety cell. 7 So no allegations or complaints that Mr. Tinner, while 0. 8 in the San Juan County jail, had ever been assaulted by 9 another inmate. 10 Α. I don't recall that. I don't recall him ever being 11 assaulted by another inmate. 12 Ο. Mr. Parker voluntarily left his employment as a law 13 enforcement officer with your agency. Correct? 14 Α. Correct. 15 And even though in your investigation report you 0. 16 indicate that you would have ultimately terminated him, 17 that didn't come about. Correct? 18 Α. Correct. 19 All right. So did Asher keep going on with his quest to Ο. 20 say that he informed people that -- I think the term was 21 used, Parker was a bad apple -- did he continue that 22 quest even after Detective Parker had voluntarily 23 resigned his position? If you can recall the 24 chronology. 25 Α. I recall the chronology. I don't recall whether --

1 yeah. I believe he did.

2	Q.	Do you know why? Was it an attempt to discredit you?
3		discredit the prosecutor? Just he couldn't let it go?
4		Do you have any sense on why he kept going on and on?
5	Α.	I have no idea. I don't.
6	Q.	When he resigned, did he tell you why he was leaving?
7	A.	No.
8	Q.	Do you know where he resides now?
9	A.	No.
10	Q.	Do you think he's still in the county?
11	A.	I haven't seen him in a number of months, so I I'm
12		not sure where he is. I know he still has property in
13		the county, but I don't know where he's residing.
14	Q.	Was it your understanding that prosecutor Gaylord was
15		going to continue with retrying Mr. Tinner based on the
16		evidence he had, despite the Brady allegations involving
17		Detective Parker?
18	A.	I don't I don't know that.
19	Q.	So I'm curious about this Martin Sinclair. I hear
20		people say he's a judge, he's an attorney, he's a good
21		friend of Asher's, and I gathered from your testimony
22		earlier today that you really didn't explore that in
23		depth.
24	A.	Correct.
25	Q.	Have you ever talked to Martin Sinclair?

¹ A. I have not.

2	Q.	Has he ever provided a sworn statement or a declaration
3		verifying his allegations about how Detective Parker may
4		have interacted at other agencies in Montana?
5		MR. COOLEY: You can't talk about any of my work
6		product. But if you know for some
7	BY M	R. McMAHON:
8	Q.	If you know from any other source other than your
9		attorney.
10	Α.	No, I don't.
11	Q.	Did anybody in your department follow up with this guy?
12	A.	I don't believe so.
13	Q.	Did anybody from the SMART team contact this Sinclair
14		and see if he has any credibility or validity as to the
15		allegations he purportedly was making to Asher?
16	A.	I don't know.
17	Q.	Based on a jury having seen Natalie Garcia testify,
18		seeing your sex crime investigator Detective Parker
19		testify, hearing evidence of DNA, Tinner's semen being
20		interchanged with her bodily fluids, could you tell us,
21		Sheriff, how all of the allegations that are being
22		levied against Detective Parker would have made any
23		difference in that criminal trial?
24	A.	No. In fact, earlier I was asked if you know, why I
25		feel Dr. Tinner is guilty, and basically everything you

1		just outlined there is really why I feel in my opinion
2		he was guilty.
3	Q.	He was guilty of sexually abusing Natalie Garcia.
4	Α.	Yes. Dr. Tinner was, yes.
5	Q.	All right. That's all I have. Thank you.
6		EXAMINATION
7	BY M	IR. COOLEY:
8	Q.	Real quickly, Sheriff. You were asked about whether
9		you've given training to your department about the need
10		for officers not to have sex with victim witnesses and
11		the like. Why is it that you don't give training on
12		that topic?
13	Α.	Well, again, it's you know, it's one of those things
14		I don't train I don't I don't give training on not
15		beating your wife. I don't give training on not kicking
16		your dog. I don't give training on, you know, not
17		murdering people.
18		It's it's a code of ethics. It's a code of
19		conduct in law enforcement. That's what law enforcement
20		is. That's what we do. And some things, you know, you
21		don't have to train on, I don't believe.
22	Q.	So were you asked about whether after the issue with
23		Detective Parker occurred, whether you took any
24		corrective action in your agency. In your opinion, was
25		there any corrective action that you needed to take?

1 Α. No. 2 MR. COOLEY: Okay. That's all the questions 3 I've got. Thanks. 4 MR. LEE: Just very briefly. 5 EXAMINATION 6 BY MR. LEE: 7 Sheriff, did you testify that when inmates at the San Ο. 8 Juan County jail are held for an extended period they're 9 transferred to the Yakima County jail? 10 Α. Yes. Currently they are. 11 And you're from Yakima. Correct? Ο. 12 Α. Correct. 13 And you visit Yakima from time to time? Ο. 14 Rarely, but, yes. Α. 15 And you're aware through being a sheriff and being aware 0. 16 of criminal activity in the state of Washington that 17 Yakima has a serious problem with criminal street gangs? 18 Α. Yes. 19 And the San Juan County jail doesn't have criminal Ο. 20 street gangs' members in the jail, does it? 21 Α. Correct. 22 But the Yakima County jail has quite a few members of 0. 23 the criminal street gangs in Yakima. Correct? 24 I believe so, but I couldn't attest to their population Α. 25 and the demographics of their population.

1	Q.	All right. The DNA evidence that was alleged to be
2		Dr. Tinner's was in the custody of Stephen Parker.
3		Correct?
4	Α.	Correct.
5	Q.	A man you have said is a liar. Correct?
6	A.	Correct.
7	Q.	All right. That's it.
8		MR. COOLEY: Okay. Seeing nothing further,
9		we'll reserve signature
10		MR. McMAHON: I want to ask one follow-up.
11		EXAMINATION
12	BY M	IR. McMAHON:
13	Q.	Based on that last question, do you have any reason to
14		suspicion that the DNA evidence that the state
15		toxicologist told the jury under oath was the semen of
16		Tinner intermixed with the bodily fluids of the victim
17		Natalie Garcia was somehow tampered with or altered in
18		any way?
19	Α.	Could you repeat the first part of that question.
20	Q.	Do you have any evidence or suspicion that Tinner's DNA
21		evidence consisting of his semen and bodily fluids that
22		was interchanged with the victim Natalie Garcia's bodily
23		fluids was somehow tampered with in any way by Detective
24		Parker?
25	Α.	I don't.

1	Q.	Do you have any explanation at all how Tinner's semen
