AGREED ORDER OF DISMISSAL
 WITHOUT PREJUDICE
 (REMAINING COUNTS)

This matter came before the Count on May 23, 2022 for a status hearing. All parties with counsel were present. The Court summarized the history of proceedings to date. Defense informed the Court that Defendant recently filed a petition for writ of *certiorari* with the Supreme Court (Docket No. 21-1451) following dismissal of her petition for writ of *habeas corpus*, affirmed by the Ninth Circuit. See Adams v. Dodge, Case No. 21-35490. The Tribe informed that Court that over the course of this case, it had lost contact with the primary victim-witness to the charges of custodial interference, recently exhausted efforts to contact the victim-witness at all known (past and present listed numbers) and through mailings without success. Resultantly, the Tribe moved to dismiss the remaining counts without prejudice. Defense did not object, and was not aware of any restriction that would prohibit dismissal without prejudice.
