CERTIFICATION FOR DETERMINATION OF PROBABLE CAUSE

I am *Doug Maya*. I am a Deputy Sheriff with the San Juan County Sheriff's Office and I conducted the investigation in San Juan County Sheriff's Office Case Number 19-005429. SECTOR citation # XXXXXXXX

There is probable cause to believe that YOUNG, JASON, S. DOB 01/04/80 committed the crime(s) of RCW 9A.56.040 THEFT 2ND DEGREE

This belief is based upon the following facts and circumstances which occurred in San Juan County, State of Washington: On 07/10/19 I was dispatched to a report of Theft at the Friday Harbor Marina. I arrived and spoke to the Harbormaster Tammy HAYES who stated one of her employees had a bicycle missing from the rack in the parking lot. Tammy stated she reviewed the security footage and found a box truck and three males later learned to be, Chris LOLL, Richard KURO, and Jason YOUNG exit the truck. I then reviewed the footage and you can clearly see all three suspects taking bicycles from the rack in parking lot and putting them in the box truck with License Plate, C14715R, White, Ford, Truck, registered to Chris LOLL. I found at one point of the footage Richard was speaking to a Port Employee who later learned to be Claes EDHAMMER. On 07/10/19 I spoke to Richard and he said he received permission from a Port Employee, it was later found no permission was ever given. Later I spoke with Claes where he stated on 07/05/19 and he asked Richard if he had received permission that day from the Assistant Harbormaster. Richard stated he had. It was found later no permission was ever given. I attempted to contact Jason with negative results. Tammy said there is no past practice of giving permission to a private citizen to remove bicycle and cut locks from the Port. Chris and Richard returned the bicycles to the Sheriff's Office. I completed a comparison on-line of pricing and found for all 8 bicycles including: Gary Fisher Wahoo, Mongoose Hilltopper, Mongoose Iloc sport, Specialized Ultra, Raleigh Roper, Jetty Express folding bikes x2, and Schwinn Traveler the total loss to be \$1488.00.
