### **Juvenile Points History**

"And finally, we have waited too long to fix our juvenile justice system, a system that lets kids get away with too much; that misses too many opportunities to turn kids around; and that leaves too many of us vulnerable to violent and dangerous young criminals. To procrastinate on any one of these issues from education to water to juvenile justice is to court disaster. The clock is ticking. A new century is coming at us like a bullet train. And it's up to us to either rise to these challenges, or watch as that train rushes by."

### **Outcome?**

- 41% of Indigenous people currently incarcerated in Washington State have at least one juvenile felony on their record.
- 39% of Black people currently incarcerated in Washington State have at least one juvenile felony on their record.





#### EHB 1324

- Prospectively & retroactively stops the practice of automatically sentencing people to longer sentences because of crimes they committed as children.
- As amended, the bill has the potential to provide resentencings for close to 1,500 people currently serving longer sentences because they were punished twice for crimes they committed as a child.

# ACLU-WA 2023 Legislative Agenda: Bill Updates

### **Legislative Session Cutoff Dates**

- January 9: First day of 2023 session
- February 17: Last day to pass bills out of policy committee (chamber of origin)
- February 24: Last day to pass bills out of fiscal committee (chamber of origin)
- March 8: Last day to pass bills out of chamber of origin







# Legislative Session Cutoff Dates (cont.)

- March 29: Last day to pass bills out of policy committee (opposite chamber)
- April 4: Last day to pass bills out of fiscal committee (opposite chamber)
- April 12: Last day (5pm) for bills to be passed on the floor (opposite chamber)
- April 23: Sine die (end of regular session)

## **2023 Legislative Priorities**

#### **Decriminalizing Drug Possession**

- ACLU-WA <u>opposes</u> E2SSB 5536, which criminalizes simple use drug possession as a gross misdemeanor.
- The bill passed out of the Senate and has been referred to House Community Safety, Justice, & Reentry.

#### **Transforming Sentencing & Reentry**

- Juvenile Points (EHB 1324) referred to Senate Law & Justice
